

Become a PG&E Supplier

Prospective suppliers must meet certain minimum qualifications that vary by product and service category.

Minimum Requirements include:

- General Liability, Auto, and Worker's Compensation certificates of insurance that meet PG&E's minimum requirements of a \$1 million policy for each area of coverage.
- Proof that your company has been operating for at least two years and is performing consistent, contracted work.
- Ability to provide five current references upon completion of work.
- Evidence that your company has a good credit rating and is financially stable.
- A U.S. Federal Taxpayer ID number or country equivalent taxpayer identification.
- Ability to collect and pay appropriate sales tax and other taxes to proper agencies.
- Ability to utilize Electronic Data Interchange (EDI) for receiving orders, confirming orders and invoicing.

Supplier Diversity

It is the policy of PG&E that Women, Minority, and Disabled Veteran-owned Business Enterprises (“WMDVBEs”) and Lesbian, Gay, Bisexual and Transgender (LGBT) enterprises (collectively, Diverse Business Enterprises or “DBEs”) shall have the opportunity to participate in the performance of Agreements resulting from wholesale electric power procurement solicitations. We encourage supplier relationships with DBEs that promote safety, reliability and affordability.

Renewable Feed-in Tariffs (ReMAT), replacing AB 1969	Up to 3 MW
Bioenergy Feed-in Tariff (BioMAT—SB 1122)	Up to 3 MW

How to Become a Certified Diverse Supplier

1. **Women- and Minority-owned Business Enterprises (WMBEs)**—except for Disabled Veteran Business Enterprises (DVBES) located in California—must register with the CPUC Clearinghouse to become certified as a diverse supplier. Visit the Supplier Clearinghouse website to download instructions and the verification application that you must complete in order to certify your business.

Disabled Veteran Business Enterprises (DVBES) located in California must obtain certification through the State of California Department of General Services.
