Better Together Nature Positive Innovation Grant Application 2024


California faces growing risks to its natural environment and unique biodiversity. Today, about 30% of California's species are threatened with extinction—more than any other state. Climate change is further threatening California's natural environment—through direct impacts to habitats and species and indirect impacts through climate-induced changes in resources such as food, water, and habitat quality and availability.

As one of the largest landowners in California, Pacific Gas and Electric Company (PG&E) has a long history of responsible stewardship of the natural environment. We are renewing our focus on environmental stewardship and are pursuing opportunities to invest in partnerships that will promote protecting and restoring land, water, and air in habitats and communities across our service area.

The Better Together Nature Positive Innovation Grant Program, funded by The PG&E Corporation Foundation (Foundation), is requesting proposals of \$100,000 to fund five projects (one in each region of PG&E's service area) in 2024 that address a specific environmental stewardship focus area:

- Land Stewardship
- Air Quality
- Water Stewardship

Eligibility

Eligible applicants will be governmental organizations (including tribal governments), educational institutions, or certified 501(c)3 nonprofit organizations/public charities. Applicants must be prepared to provide documentation to demonstrate they meet the Foundation's criteria for charitable giving. Applicants must be the grantee and not a fiscal sponsor for another organization.

Priority will be given to projects that address the needs of disadvantaged and/vulnerable communities.

Organizations are invited to submit one application that addresses any of the three focus areas (Land Stewardship, Air Quality, or Water Stewardship) in any of the five regions. One grantee will be selected from each region. Grants can cover any stage of a project, including but not limited to planning, construction, design, education, and coordination.

Organizations that have been awarded a Nature Positive Innovation Grant in 2022 or 2023 are **ineligible** for this grant program.

Evaluation Criteria

Proposals must comply with all submission instructions and guidelines to be considered for funding. To inform your proposal, applicants may refer to the glossary of terms and the list of sample resources that are included at the end of this document, after the application questions. The Foundation will evaluate all proposals according to the application questions below.

Grant Requirements

Funded applications will be expected to complete the following actions:

- Respond to a questionnaire about the project.
- Sign, date and submit the certification document which appears on page 6.
- Participate in quarterly update calls with representatives and agents of The Foundation.
- Provide a report to the Foundation detailing project actions, stakeholders engaged, additional resources leveraged, and other outcomes, including an executive summary.

There is no deadline for completing grant projects, but we suggest grantees set a timeline to complete their work no longer than 18 months after receiving the grant.

Glossary of Terms

- Nature Positive¹: enhancing the resilience of our planet and societies to halt and reverse nature loss.
- **Air Quality:** Examples include but are not limited to: Projects or implementation of processes that reduce particulates due to human caused pollution, remove solid, liquid or gaseous contaminants from the air, improve air quality due to the planting of vegetation or promote adoption of technology or practices that are beneficial to local air quality.
- **Environmental Stewardship**²: The responsible use and protection of the natural environment through conservation and sustainable practices to enhance ecosystem resilience and human well-being
- Land Stewardship: Activities that enhance or improve damaged or blighted conditions. Examples include but are not limited to: Streambank stabilization projects, community gardens, creation or rehabilitation of local parks or outdoor green spaces.
- **Partner:** Individual(s) or organization(s) that will be involved in the design and implementation of the proposed work.
- **Stakeholder:** Individual(s) or organization(s) impacted by the environmental challenge that the project is working to address, who occupy the area where the project will be implemented, and/or are otherwise affected by the design and implementation of the project.
- Water Stewardship: Examples include but are not limited to: Projects that enable the protection of the aquifer, stream or river restoration projects that provide an ecological functional lift, community water quality improvement programs.
