### Community Wildfire Safety Program PG&E Virtual Safety Town Hall – Mendocino, Humboldt, Trinity, Siskiyou – Post-Event Report

On April 7, 2021, PG&E held an online safety town hall, in accordance with the Settlement Agreement approved by the May 7, 2020, California Public Utilities Commission (CPUC) Decision (D.) 20-05-019 Order Instituting Investigation (OII) regarding 2017 and 2018 wildfires.

PG&E is listening to customer feedback to help understand how we can continue to improve wildfire prevention efforts, including the Public Safety Power Shutoff (PSPS) program. The purpose of the event was to share safety, utility service-related information and customer resources for Mendocino, Humboldt, Trinity and Siskiyou county residents, gather input and respond to questions. Due to COVID-19 health and safety guidelines, the safety town hall was conducted virtually.

The event featured a 30-minute presentation on PG&E's wildfire prevention plans, an overview of 2020 Public Safety Power Shutoff (PSPS) events and weather-related safety tips, followed by a 45-minute Q&A session. Participants could either join via the virtual conference platform or by calling into a toll-free number. Closed captioning was available in English, Spanish and Chinese.

# Event Outreach

PG&E conducted outreach through a variety of channels to drive attendance to the event. Outreach included:

# Question and Answer Session Summary

Throughout the town hall, participants submitted questions and comments for PG&E's subject matter experts through a Q&A function on the virtual webinar platform. A total of 16 questions and comments were received.

The Q&A portion focused on the following themes:

- Vegetation management and how to address an area of concern
- Tree removal and plans to re-landscape around Harris Substation
- How a customer can address treework they disagree with
- Vegetation team tree knowledge and customer service
- PSPS advanced and ongoing notifications
- Factors that cause a PSPS event and anticipated changes for this wildfire season
- Reflection of enhanced system hardening work on customer bills
- Anticipated work being done for this season due to continued drought in Northern California
- Support of PG&E restoration work in the local community during PSPS events
- Installation of thermal cameras in Mendocino County
- Concerns regarding tree removal after vegetation work is conducted







# APPENDIX B: QUESTIONS RAISED DURING THE EVENT

The below questions/comments have been listed in the order received.

- Does this town hall apply to Sonoma County, also? Thanks.
- Recently one of Eureka's nicest groove of Redwoods (approx. 150 years old) were cut down at Harris Substation. Why was this done and does PG&E plan on landscaping around the SUB?
- How will all these upgrades & enhancement affect our PG&E bill?
- How much notice will there be for PSPS events?
- Greetings-- it is my understanding that PG&E may be adjusting their triggers for PSPS events for this fire season-like wind gust. Can you please share?
- What became of the lumber from the cutting at the Harris substation?
- Are there unusual challenges to transmission or vegetation management in Mendocino county?
- What if I disagree with tree work being done?
- How best can we assist or otherwise not hamper the work of your representatives in the field during these events?
- Most of Northern California is in a substantial drought, how is PG&E preparing for yet another record breaking fire season?
- Is there a resource for recommended measures for coping with loss of power during a PSPS? For example, are backup power supplies recommended, and/or other equipment or provisions?
- Why are different crews assigned to treatment around the poles than around the lines? It's confusing to have so many crews visiting my property repeatedly.
- Sumeet is impressively knowledgeable! It always comes down to weighing the potential risk vs. cost. Let's hope for unusual summer rains with NO lightening.
- I had to identify trees for a crew that had only written directions and who didn't know a fir from an oak. I have encountered a crew that didn't speak English well. What's with this?
- How many new thermal cameras do you hope to install this year, esp. in mendocino county?
- I am concerned that when you remove trees, you only move half the tree, and also leave flammable branches on the ground. Will you make more of an effort to remove all the tree, not cut it halfway down?
