Directions:

1. Ask your landlord to complete and sign the Owner Authorization Form.
2. Join the SmartAC program by calling **1-866-908-4916** or completing the SmartAC online enrollment form at **www.pge.com/SmartAC**.
3. Provide the signed Owner Authorization Form to the SmartAC installer who comes to install or activate your SmartAC device. We will not be able to install SmartAC if you have not secured authorization from the property owner or property manager.

Dear Landlord/Property Manager,

Your tenant is seeking your permission to enroll in Pacific Gas and Electric Company's (PG&E) SmartAC™ program that gives your tenant the ability to fight power interruptions. Installed on or near your air conditioner, SmartAC technology can be remotely activated to reduce your air conditioner's demand for electricity—temporarily and without sacrificing your tenant's control or comfort.

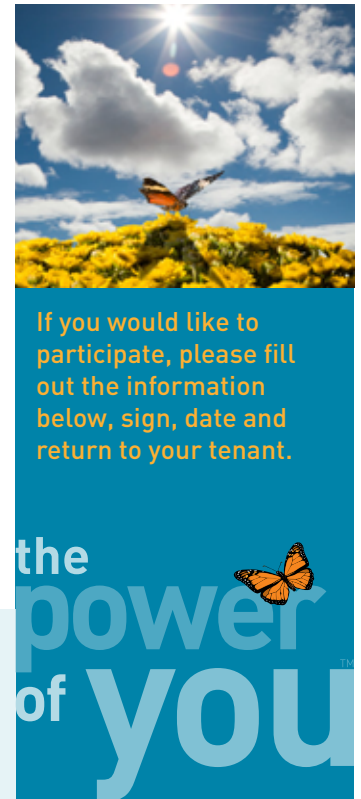
SmartAC technology is only activated in the event of a state or local energy supply emergency, only between May 1 and October 31—and never for more than six hours per day.

SmartAC installation and technology are provided free by PG&E and come with PG&E's free technical support and customer service, as long as you or your tenants remain in the SmartAC program.

To participate, your property must meet the following qualifications:

- Have a central air conditioning or heat pump unit in a suitable operating condition. Evaporative/swamp coolers and window units do not qualify.
- Be a home, duplex, townhome, condominium, apartment or small business space.
- Have tenant[s] who are not defined as life support or medical baseline customer[s].
