ADVICE 1994-E

Public Utilities Commission of the State of California (CPUC)

Pacific Gas and Electric Company (the Company) hereby submits, in accordance with Section XI.B of General Order (GO) 131-D, notice of the relocation of a power line in the City of Wasco. The Notice described in GO 131-D Section XI., Paragraph C, is submitted as Attachment I.

The Company has been requested by Kenneth Lee Wedel and others to relocate a portion of the existing Semitropic-Famosa 70 kilovolt power line which is located along the north side of Highway 46, near the intersection of Peters Street in the City of Wasco. The relocation is required to accommodate the proposed street improvements associated with a land development. The Company will relocate one pole approximately 46 feet northwesterly of its existing location, and the total length of line affected by the relocation is approximately 650 feet. Construction is scheduled to begin in June 2000, and the new facilities should be in operation by August 2000.

Pursuant to Section III, Paragraph B, Subsection 1(c) of GO 131-D, the relocation of this power pole is exempt from a Permit to Construct. Subsection 1(c) states that a Permit to Construct is not required for "the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersecting of additional support structures between existing support structures."

Additionally, GO 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs). Based upon the standard that "low cost" mitigation measures not exceed 4% of the total project costs, there are no "no cost" or "low cost" measures to be employed.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

The Company requests that this advice filing become effective on **June 26, 2000**, which is 40 days after the date of filing. (In accordance with GO 131-D, construction will not begin until 45 days after notice is first published.)
