Subject—Entries to the TCBA/GABA for the Estimated Market Value of Non-Nuclear Generating Facilities

Purpose

In accordance with Ordering Paragraph 22 of Decision (D.) 00-02-048, Pacific Gas and Electric Company (PG&E) hereby confirms that the adjusted entries to its Transition Cost Balancing Account (TCBA) and the Generation Asset Balancing Account (GABA) are in compliance with D. 00-06-004, dated June 8, 2000, and D. 00-02-048, dated February 17, 2000, both in Application (A.) 98-09-003, the 1998 Annual Transition Cost Proceeding (ATCP). The entries are described in Advice 2048-E filed concurrently with this advice filing.¹
