Subject: Applicant Design Further Open to Small Commercial/Industrial Line and Service Extensions

Purpose

This advice filing is to notify the Commission and interested parties that Pacific Gas and Electric Company (the Company) is further opening applicant design in accordance with Decision (D.) 97-12-099. The Company proposes to expand the Applicant Design Option to all projects where the electric main switch size is 400 amps or less and for gas projects using 1000 CFH or less. This filing will also include all pressure sets up to and including 1 lb.

Background

In D.95-12-013, the Commission approved a 24-month pilot program to test the feasibility of applicants designing distribution facilities for gas and electric service to their residential projects. On December 16, 1997, the Commission issued D.97-12-099 finding that the applicant design pilot program for new residential gas and electric distribution line extensions was a success and concluded that the program should be implemented as a regular utility tariff option for new and temporary residential distribution facilities. As a result, the Company filed Advice 2081-G/1765-E establishing the Applicant Design Option for New Residential Installations.

In addition, Ordering Paragraph 4 of D.97-12-099 stated that within three years of the date specified in Ordering Paragraph 1 (July 1, 1998), the Applicant Design Option should be open to applicants requesting commercial or industrial service less than 50 kV and up to 60 psig.¹ This decision specifies that the third-party designers must also meet the utilities pre-qualification requirements for such projects.

Therefore, pursuant to D.97-12-099, the Company is notifying the Commission that it is opening the Applicant Design Option to applicants where the main electric

switch size is 400 amps or less and for gas projects using 1000 CFH or less. The Company will complete the opening up of applicant design required by D.97-12-099 for larger projects by July 1, 2001.

This advice filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other schedule or rule.

Effective Date

The Company proposes to implement the expansion of the Applicant Design Program on **February 1, 2001**.
