**Subject:** Supplemental Testimony for Route Selected in D.01-05-059

## Purpose

This Advice Letter provides notice of the Supplemental Testimony (Cost Estimate) of Pacific Gas and Electric Company (The Company) Responding to Ordering Paragraph 4 of Decision (D.) 01-05-059, issued May 14, 2001, and mailed May 17, 2001, as required by that paragraph.

#### **Background**

In accordance with Ordering Paragraph 4 of (D.) 01-05-059, the Final Decision granting a Certificate of Public Convenience and Necessity for the Northeast San Jose Transmission Reinforcement Project (the "Final Decision"), the Company hereby submits this Advice Letter providing notice of availability of its Supplemental Testimony containing its cost estimate for the route selected by the Final Decision. the Company prepared this cost estimate using substantially the same methods and assumptions as it used in preparing the estimates it previously submitted to the Commission in this proceeding Application (A.) 99-09-029 for its proposed route and the routes analyzed in the Draft Environmental Impact Report, with one notable exception. As the Final Decision directs, the Company's land cost estimates are supported by a current, expert appraisal that was prepared during May and June 2001. the Company's Project Manager, Tom Marki, who testified in the hearings in this proceeding, is the sponsor of this Supplemental Testimony.

As the Final Decision directs, the Company is serving the Supplemental Testimony on the Appearance and State service lists in A.99-09-029. Consistent with that direction, and due to the specific nature of this filing and the number of non-parties on the Advice Letter service list, the Company is not providing the Supplemental Testimony to non-parties receiving this Advice Letter.
