**Subject: Relocation of a Portion of Line #702 for Robert Colston
Development of Tract 6022 in the City of Taft in the County of
Kern**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4 of the construction of facilities that are exempt from a Permit to Construct.¹

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List which comply with the noticing requirements found in G.O. 131-D, Section XI, Subsections B and C.

Background

The Company has been requested by Robert Colston to relocate a portion of the existing Taft-Maricopa 70 Kilovolt (kV) Line #740 just South of the Company's Taft Substation in the City of Taft, County of Kern. This existing wood pole line is currently within a utility easement that will be replaced in a new location East of the current location. The Company will relocate approximately 900 feet of the existing 70 kV line to accommodate development within Tract No. 6022 near Philippine Street and Quail Court. The new location will be compatible with the new housing as proposed by the developer. Two poles will be removed and two new wood poles will be installed. Construction is scheduled for May 2002 and is scheduled to be completed soon thereafter.

¹ The Company reserves all legal rights to challenge the decisions or statutes under which it has been required to make this advice filing, and nothing in this advice filing constitutes a waiver of such rights. Also, the Company reserves any additional legal rights to challenge the requirement to make this advice filing by reason of its status as a debtor under Chapter 11 of the Bankruptcy Code, and nothing in this advice filing constitutes a waiver of such rights.

This project qualifies as exempt from Permit to Construct filing requirements pursuant to G.O. 131-D, Section III, Subsection B.1.c, which exempts, "the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures."

- Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs). The Company will install taller structures than normal to reduce the EMF fields at ground level.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Persons or groups may protest the proposed construction if they believe that the Company has incorrectly applied for an exemption or that the conditions set out in G.O. 131-D, Section III.B.2, exist.

Effective Date

The Company requests that this advice filing become effective on **May 15, 2002**, which is 40 days after the date of filing. (In accordance with G.O. 131-D, construction will not begin until 45 days after notice is first published.)
