**Subject: Allocation of 2002 CARE Budget Between Electric and Gas
Departments - Supplemental Filing**

Pacific Gas and Electric Company (PG&E) hereby submits this supplemental advice letter for filing the allocation of the authorized program year (PY) 2002 CARE budget between the electric and gas departments. This supplemental filing supersedes the allocation proposed in Advice 2410-G/2284-E.¹

Purpose

This filing is made pursuant to Ordering Paragraph 1 of Decision (D.) 02-09-021, which requires PG&E to allocate the PY 2002 CARE budget between the electric and gas budgets.²

Consistent with currently adopted practice from D. 89-07-062, PG&E allocates the CARE administrative costs between electric and gas departments in the same proportion as the gas and electric program discounts.³

At the request of the Energy Division, this supplemental filing uses data from Table 6 of the twelve most recent Monthly Status Reports on the Results of Rapid Deployment Efforts, as a basis to assign PY 2002 CARE administrative expenditures to the electric and gas departments.

¹ PG&E reserves all legal rights to challenge the decisions or statutes under which it has been required to make this advice filing, and nothing in this advice filing constitutes a waiver of such rights. Also, PG&E reserves any additional legal rights to challenge the requirement to make this advice filing by reason of its status as a debtor under Chapter 11 of the Bankruptcy Code, and nothing in this advice filing constitutes a waiver of such rights.

² The Commission states on page 39 of D. 02-09-021, "SDG&E and PG&E will need to reallocate their CARE administrative expenditures between their gas and electric departments to reflect our adopted budgets. We direct them to file Advice Letters for this purpose."

³ The Commission states on page 37 of D. 89-07-062, "In order to be consistent, administrative costs should be allocated between gas and electric operations in the same proportion as gas and electric program discounts."

As shown in the following table, PG&E proposes to assign 78 percent of the PY 2002 CARE administrative expenditures to the electric department and 22 percent to the gas department.

⁴ The CARE program discount data is from Table 6 of the twelve most recent Monthly Status Reports on the Results of Rapid Deployment Efforts, filed in compliance with Ordering Paragraph 17 of D. 01-05-033, issued May 7, 2001. The electric CARE discount is for the 20% discount only, and it does not include the avoided surcharges.
