**Subject: Report the Gain on Sale of Streetlight System Sold to Santa Rosa**

**Purpose**

In accordance with Ordering Paragraph 2 of Decision (D.) 01-06-005, dated June 7, 2001, Pacific Gas and Electric Company (PG&E) hereby reports the gain realized from the sale of a streetlight system to the City of Santa Rosa.

**Background**

Pursuant to Public Utilities Code Section 851, PG&E filed Application (A.) 01-01-038 on January 25, 2001, and requested Commission approval to sell and convey PG&E's streetlight system located in Santa Rosa. The Commission approved PG&E's request in D. 01-06-005, dated June 7, 2001. Ordering Paragraph 2 of D. 01-06-005 required PG&E to file an advice letter to report the gain on sale of the streetlight system within 90 days of the sale and conveyance, which occurred on December 5, 2002.

**Protests**

Anyone wishing to protest this filing may do so by sending a letter by **March 23, 2003**, which is 20 days from the date of this filing. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. Protests should be mailed to:
