(Pacific Gas and Electric Company ID U 39 E)**

**Subject: 2000 Annual Transition Cost Proceeding – TCBA
Accounting Adjustments Pursuant to Decision 03-02-047**

Purpose

Pacific Gas and Electric Company (PG&E) hereby submits its compliance advice letter confirming the accounting adjustments recorded in the Transition Cost Balancing Account (TCBA) and related memorandum accounts pursuant to Decision (D.) 03-02-047 in the 2000 Annual Transition Cost Proceeding (ATCP) (Application 00-09-001).

Background

On February 27, 2003, the Commission issued D. 03-02-047 in PG&E's 2000 ATCP. Ordering Paragraph 3 of D. 03-02-047 states "PG&E shall file and serve a compliance advice letter to confirm the adjusted entries in its TCBA and related memorandum accounts."

In Ordering Paragraph 1 of D. 03-02-047, the Commission approved all of PG&E's revenue and costs recorded to the Transition Cost Balancing Account (TCBA) and TCBA-related memorandum account from July 1, 1999, through June 30, 2000. Ordering Paragraph 2 of the decision authorized PG&E to record the electric supply procurement costs in the TCBA for period January 1, 1999, through June 30, 2000.

TCBA Adjustments

As described above, the Commission has found that all of PG&E's revenues and costs were appropriately recorded in both the TCBA and TCBA-related memorandum account from July 1, 1999, through June 30, 2000. PG&E confirms that there are no adjustments necessary or required to its TCBA and other TCBA-related memorandum accounts.

Protests

Anyone wishing to protest this filing may do so by sending a letter by **April 9, 2003**, which is 20 days from the date of this filing. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. Protests should be mailed to:
