**Subject: Update Four Service Provider Lists Per D. 97-12-088**

**Purpose**

As directed in Affiliate Rule IV.C.2, (Decision 97-12-088), Pacific Gas and Electric Company hereby submits its semi-annual update of its lists of service providers that contain affiliates.<sup>1</sup> Pacific Gas and Electric Company requests authorization to continue to offer the following lists to customers, which contain one or more affiliates of Pacific Gas and Electric Company. These lists were most recently approved effective December 11, 2002, in Advice 2419-G/2297-E.

- Super List: List of all service providers (Attachment A), which is updated monthly. This list is provided to customers or third parties requesting information about an affiliate company for which a more specific list has not been approved in accordance with Affiliate Rule IV.C.2. Parties wishing to be placed on the list must complete and submit the request form (Attachment B) to this filing;
- List of Direct Access Service Providers (Attachment C) which will be updated at least monthly;
- Natural Gas Suppliers List (Attachment D); and
- Core Transport Agent (CTA) List (Attachment E) which will be updated at least monthly.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any rate schedule or rule.

**Protests**

Anyone wishing to protest this filing may do so by sending a letter by **May 21, 2003**, which is 20 days from the date of this filing. The protest must state the
