**Advice 2408-E
(Pacific Gas and Electric Company ID U39 E)**

Public Utilities Commission of the State of California

Subject: West Fresno – California Avenue 115 Kilovolt (kV) Power Line

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4 of the construction of facilities that are exempt from a Permit to Construct.¹

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

The Company proposes to construct a new 115 kV wood pole power line in the City of Fresno to improve reliable electric service to customers in the downtown Fresno area. It will extend from the existing West Fresno-McCall Power Line located near Annadale Avenue and Fruit Avenue to the existing California Avenue Substation, located near California Avenue and Orange Avenue in Fresno. The project will replace 3.2 miles of existing power line facilities, replace the existing wire (conductor) on approximately 0.2 miles of existing power line facilities, and construct approximately 1.5 miles of new power line facilities within existing franchise areas and rights-of-way. Construction is tentatively scheduled to begin in January 2004, or as soon as possible thereafter, and to be completed in June 2004, or as soon as possible thereafter.

¹ The Company reserves all legal rights to challenge the decisions or statutes under which it has been required to make this advice filing, and nothing in this advice filing constitutes a waiver of such rights. Also, the Company reserves any additional legal rights to challenge the requirement to make this advice filing by reason of its status as a debtor under Chapter 11 of the Bankruptcy Code, and nothing in this advice filing constitutes a waiver of such rights.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1. (b), (e), and (g), which exempts, "the replacement of existing power line facilities or supporting structures with equivalent facilities or structures;" "The placing of new or additional conductors, insulators, or their accessories on supporting structures already built;" and "power line facilities or substation to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts."

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs).

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4 percent or less of the total project cost, no "no cost" or "low cost" measures will be employed.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Persons or groups may protest the proposed construction if they believe that the Company has incorrectly applied for an exemption or that the conditions set out G.O. 131-D, Section III, B.2 exist.

Effective Date

The Company requests that this advice filing become effective on **September 28, 2003**, which is 40 days after the date of filing. (In accordance with G.O. 131-D, construction will not begin until 45 days after notice is first published.)
