**Subject: Notification of Completed Transfer of Water Rights Easements
in Accordance with D. 04-04-056**

Purpose

In accordance with Ordering Paragraph 5 of Decision (D.) 04-04-056, dated April 22, 2004, Pacific Gas and Electric Company (PG&E) hereby submits for filing to the Commission its notice that the transfer of separate water rights easements to seven private property owners in Shasta County has been completed.

Background

Pursuant to Public Utilities Code Section 851, PG&E filed Application (A.) 03-12-015 on December 8, 2003, and requested Commission approval to grant separate water rights easements to seven private property owners in Shasta County for the installation, operation, maintenance and use of domestic water wells. The Commission approved that request in D. 04-04-056, dated April 22, 2004. The decision included an order to notify the Commission of the completed transfer within 30 days of issuing the grants.

Ordering Paragraph 5 states:

"Within 30 days of issuing the grants, PG&E shall file an advice letter with the Commission noticing the completed transfer."

The transfer of separate water rights easements to the seven private property owners in Shasta County was completed and recorded on June 25, 2004.

Protests

Anyone wishing to protest this filing may do so by sending a letter by **July 26, 2004**, which is 20 days from the date of this filing. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. Protests should be mailed to:
