Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4 of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in GO 131-D, Section XI, Subsections B and C.

**Background**

Pacific Gas and Electric Company has been requested by the developer of Aqua Pool and Spa in Manteca to relocate a portion of the existing Lee 60kV Tap wood pole line approximately 10 feet north to avoid a conflict with proposed Moffet Blvd. street improvements. The proposed relocation to a new franchise position begins at the intersection of Woodward Road and Moffet Blvd., continues southeasterly on Moffet Blvd. approximately 1000 feet and includes 4 new poles replacing 3 existing poles. Two of the new poles are approximately 10 feet taller than the existing wood poles they replace, and one new pole approximately 95 feet tall and is being installed and relocated to replace an existing 55 foot wood pole. An additional new pole will be approximately 80 feet tall. Construction is scheduled to begin in August 2005, or as soon as possible thereafter, and the new facilities are planned to be in operation in September 2005, or as soon as possible after project completion.

This project qualifies as exempt from Permit to Construct filing requirements pursuant to G.O. 131-D, Section III, B, 1, which exempts;

- “the minor relocation of existing powerline facilities, or the intersetting of additional supporting structures between existing supporting structures, up to 2000 feet in length.” and
- “power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement.”

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ “no cost” and specified “low cost” measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company’s “EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution.” The following measure will be implemented: pole heights will be 5 feet taller than otherwise required to reduce magnetic fields at ground level.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

### **Protests**

## NOTICE OF PROPOSED CONSTRUCTION

Project Name: Lee 60kV Tap Relocation Project for Aqua Pool and Spa, City of Manteca, County of San Joaquin  
 ADVICE LETTER NUMBER: 2684-E

Pacific Gas and Electric Company has been requested by the developer of Aqua Pool and Spa in Manteca to relocate a portion of the existing Lee 60kV Tap wood pole line approximately 10 feet north to avoid a conflict with proposed Moffet Blvd. street improvements. The proposed relocation to a new franchise position begins at the intersection of Woodward Road and Moffet Blvd., continues southeasterly on Moffet Blvd. approximately 1000 feet, and includes 4 new wood poles replacing 3 existing wood poles. Two of the new poles are approximately 10 feet taller than the existing wood poles they replace, and one new pole is approximately 95 feet tall and is being installed and relocated to replace an existing 55 foot wood pole. An additional new pole will be approximately 80 feet tall. Construction is scheduled to begin in August 2005, or as soon as possible thereafter, and the new facilities are planned to be in operation in September 2005, or as soon as possible after project completion.

**Electric and Magnetic Fields (EMF):** Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." The following measure will be implemented: pole heights will be 5 feet taller than otherwise required to reduce magnetic fields at ground level.

**Exemption from CPUC Authority:** CPUC General Order 131-D, Section III.B, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- The minor relocation of existing power line facilities, or the intersetting of additional supporting structures between existing supporting structures, up to 2000 feet in length.
- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
