Subject: Notice of Proposed Construction of Facilities Pursuant to General Order 131-D, Sycamore Creek-Notre Dame-Table Mountain 115kV Relocation for the City of Chico, Manzanita Avenue Street Improvement Project, County of Butte

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4 of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in GO 131-D, Section XI, Subsections B and C.

Background

Pacific Gas and Electric Company has been requested by the City of Chico to relocate a 948-foot portion of the Sycamore Creek-Notre Dame-Table Mountain 115kV wood pole line approximately 5 feet south to avoid a conflict with proposed Manzanita Avenue street improvements. The proposed relocation begins at the intersection of Manzanita Avenue and Wildwood Avenue, and continues southeasterly on Manzanita Avenue approximately 948 feet. Four new wood poles will replace 4 existing wood poles; two of the new poles are approximately 10 feet taller than the existing poles to provide proper clearance and EMF mitigation. Construction is scheduled to begin in October 2005, or as soon as possible thereafter, and the new facilities are planned to be in operation in October 2005, or as soon as possible after project completion.

This project qualifies as exempt from Permit to Construct filing requirements pursuant to G.O. 131-D, Section III, B, 1, which exempts;

- “the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.” and
- “the minor relocation of existing power line facilities, or the intersetting of additional supporting structures between existing supporting structures, up to 2000 feet in length.” and
- “power line facilities or substations to be located in an existing franchise, road widening setback easement.”

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ “no cost” and specified “low cost” measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company’s “EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution.” The following measure will be implemented: pole heights will be 5 feet taller than otherwise required to reduce magnetic fields at ground level.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Project Name: Sycamore-Notre Dame-Table Mountain 115kV Relocation for the City of Chico, Manzanita Avenue Street Improvement Project, County of Butte
ADVICE LETTER NUMBER: 2708-E

Pacific Gas and Electric Company has been requested by the City of Chico to relocate a 948-foot portion of the Sycamore Creek-Notre Dame-Table Mountain 115kV wood pole line approximately 5 feet south to avoid a conflict with proposed Manzanita Avenue street improvements. The proposed relocation begins at the intersection of Manzanita Avenue and Wildwood Avenue, and continues southeasterly on Manzanita Avenue approximately 948 feet. Four new wood poles will replace 4 existing wood poles; two of the new poles are approximately 10 feet taller than the existing poles to provide proper clearance and EMF mitigation. Construction is scheduled to begin in October, 2005, or as soon as possible thereafter, with project completion approximately 2 weeks after commencement of construction.

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." The following measure will be implemented: pole heights will be 5 feet taller than otherwise required to reduce magnetic fields at ground level.

Exemption from the CPUC Authority: CPUC General Order 131-D, Section III.B, exempts projects meeting specific conditions from the CPUC's requirements to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- "the minor relocation of existing power line facilities up to 2,000 feet in length,"
- "the replacement of existing power line facilities or supporting structures with equivalent facilities or structures," and
- "power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement."

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
