Subject: Notice of Proposed Construction of Facilities Pursuant to General Order 131-D, Project Name: Atlantic-Pleasant Grove No. 1 and No. 2 60kV Relocation and Replacement of One Tower on the Rio-Oso-Tesla 230kV for the Fountains Shopping Center Development, City of Roseville, County of Placer

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4 of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in GO 131-D, Section XI, Subsections B and C.

Background

Pacific Gas and Electric Company has been requested by the developer of the Fountains Shopping Center in Roseville to relocate a portion of the existing Atlantic-Pleasant-Grove 60kv No. 1 and No. 2 wood pole line approximately 40 feet north to avoid a conflict with a proposed Fountain Shopping Center development. The proposed relocation within PG&E existing easement is located adjacent to and continues west of the intersection of Harding Blvd. and Roseville Parkway approximately 1750 feet, and includes adding two new tubular steel towers, 100 and 120 feet tall, which will replace 8 existing wood poles. The project also includes replacement of one existing lattice steel tower on the Rio Oso-Tesla 230kV transmission line with a 140 feet tall tubular steel pole to accommodate the new development. Construction is scheduled to begin in November, 2005, or as soon as possible thereafter, and the new facilities are planned to be in operation in November, 2005, or as soon as possible after project completion.

This project qualifies as exempt from Permit to Construct filing requirements pursuant to G.O. 131-D, Section III, B, 1, which exempts;

- "the minor relocation of existing power line facilities, up to 2000 feet in length," and
- "power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement."

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." The following measure will be implemented: pole heights will be 5 feet taller than otherwise required to reduce magnetic fields at ground level.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Pacific Gas and Electric Company has been requested by the developer of the Fountains Shopping Center in Roseville to relocate a portion of the existing Atlantic-Pleasant-Grove 60kV No. 1 and No. 2 wood pole line approximately 40 feet north to avoid a conflict with a proposed Fountain Shopping Center development. The proposed relocation within PG&E's existing easement is located adjacent to and continues west of the intersection of Harding Blvd. and Roseville Parkway approximately 1750 feet, and includes adding two new tubular steel towers, 100 and 120 feet tall, which will replace 8 existing wood poles. The project also includes replacement of one existing lattice steel tower on the Rio Oso-Tesla 230kV transmission line with a 140 feet tall tubular steel pole to accommodate the new development. Construction is scheduled to begin in November, 2005, or as soon as possible thereafter, and the new facilities are planned to be in operation in November, 2005, or as soon as possible after project completion.

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." The following measure will be implemented: pole heights will be 5 feet taller than otherwise required to reduce magnetic fields at ground level.

Exemption from CPUC Authority: CPUC General Order 131-D, Section III.B, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- "the minor relocation of existing power line facilities, up to 2000 feet in length," and
- "power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement."

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
