for the Relocation of Borden-Coppermine 70 Kilovolt Power Line,
County of Madera

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

The Company has been requested by Pacific Ethanol, Inc. (Developer), to relocate five poles in the existing Borden-Coppermine 70 kilovolt power line within a franchise located in the County of Madera to allow improvements to be made to Avenue 12 in conjunction with Developer's project. The project is located along Avenue 12 approximately one mile east of California State Freeway 99 just south of the city of Madera. The Company will relocate five poles by moving them approximately 25 feet to the south. The five poles will be approximately ten feet taller due to terrain change and EMF mitigation. The Company will also install two new stub pole and guy appurtenances to support the relocated line. Work will commence in January, 2006, or as soon thereafter as possible, and will be completed by February, 2006, or as soon thereafter as possible.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsections B.1.c, which exempt the following:

c) the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs). The following measures are proposed for this project:

- The five poles will be raised five feet taller than otherwise required to reduce public exposure to EMF at ground level.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Borden-Coppermine 70 Kilovolt Power Line Relocation for Pacific Ethanol, Inc.
ADVICE LETTER NUMBER: 2730-E

Proposed Project: Pacific Gas and Electric Company (PG&E) has been requested by Pacific Ethanol, Inc. (Developer), to relocate five poles in the existing Borden-Coppermine 70 kilovolt power line within a franchise located in the County of Madera. The power line will be relocated into a new easement (to be granted by Developer and adjacent property owner to the west) and will allow improvements to be made to Avenue 12 in conjunction with Developer's project. The project is located along Avenue 12 approximately one mile east of California State Freeway 99. PG&E will relocate five poles by moving them approximately 25 feet to the south. The five poles will be approximately ten feet taller due to terrain change and EMF mitigation. PG&E will also be installing two new stub pole and guy appurtenances. Each stub pole and guy will consist of a span guy attached to a stub pole then anchored with a guy into the ground. Work will commence in January, 2006, or as soon thereafter as possible, and will be completed by February, 2006, or as soon thereafter as possible.

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." The following measure is proposed for this project:

- The five poles will be raised five feet taller than otherwise required to reduce public exposure to EMF at ground level.

Exemption from CPUC Authority: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- c) the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
