131-D, for the Relocation of King City-Coburn #1 60kV Power  
Line in the City of Greenfield, County of Monterey**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

The Company has been requested by a developer, Creek Bridge Homes, to relocate four poles in the existing King City Coburn #1 60 kilovolt power line within an easement located in the City of Greenfield, County of Monterey. Four wood poles will be removed and replaced with three taller wood poles within the existing alignment and easement. The three new poles will be approximately ten feet taller due to terrain changes and EMF mitigation. The power line will be relocated to allow improvements to be made along El Camino Real in conjunction with the developer's project in southern Greenfield. Work will commence in March, 2006, or as soon thereafter as possible, and will be completed by April, 2006, or as soon thereafter as possible.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsections B.1.c, and g, which exempt the following:

- c) the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement.

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs). The following measures are proposed for this project:

- The three new poles will be raised five feet taller than otherwise required to reduce public exposure to EMF at ground level.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

### **Protests**

## NOTICE OF PROPOSED CONSTRUCTION

**PROJECT NAME:** King City-Coburn #1 60 Kilovolt Power Line Relocation, City of Greenfield, County of Monterey  
**ADVICE LETTER NUMBER:** 2780-E

**Proposed Project:** Pacific Gas and Electric Company (PG&E) has been requested by a developer, Creek Bridge Homes, to relocate four poles in the existing King City Coburn #1 60 kilovolt power line within an easement located in the City of Greenfield, County of Monterey. Four wood poles will be removed and replaced with three taller wood poles within the existing alignment and easement. The three new poles will be approximately ten feet taller due to terrain changes and EMF mitigation. The power line will be relocated to allow improvements to be made along El Camino Real in conjunction with the developer's project in southern Greenfield. Work will commence in March, 2006, or as soon thereafter as possible, and will be completed by April, 2006, or as soon thereafter as possible.

**Electric and Magnetic Fields (EMF):** Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." The following measure is proposed for this project:

- The three new poles will be raised five feet taller than otherwise required to reduce public exposure to EMF at ground level.

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- c) the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- g) power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
