**Subject: Notice of Proposed Construction of Facilities Pursuant to
General Order 131-D, Western Digital Electric Substation
Transmission Service, City of Fremont**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

Pacific Gas and Electric Company (PG&E Co.) has been requested by Western Digital Corporation to provide electric transmission service to a substation being constructed by Western Digital Corporation at 43941 Osgood Road in the City of Fremont. PG&E Co. plans to install a new steel pole in line between two existing towers on the Newark to Nummi 115 kilovolt electric power line. The new steel pole is planned to be located approximately 60 feet south of the Auto Mall Parkway and approximately 500 feet west of Osgood Road. PG&E Co. will install three electrical conductors for a distance of about 80 feet between the new tubular steel pole and the substation. Construction activities are scheduled to begin in mid-May, 2006, or as soon as possible thereafter, and project completion is scheduled for late May or early June, 2006, or as soon as possible thereafter.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, B, Section 1 (c). Section III, B, Section 1 (c) states that a Permit to Construct is not required for "the minor relocation of power line facilities, or the intersetting of additional supporting structures between existing supporting structures...."

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs). The following measures are proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low cost" measures will be employed.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Proposed Project: Pacific Gas and Electric Company (PG&E Co.) has been requested by Western Digital Corporation to provide electric transmission service to a substation being constructed by Western Digital Corporation at 43941 Osgood Road in the City of Fremont. PG&E Co. plans to install a new steel pole in line between two existing towers on the Newark to Nummi 115 kilovolt electric power line. The new steel pole is planned to be located approximately 60 feet south of the Auto Mall Parkway and approximately 500 feet west of Osgood Road. PG&E Co. will install three electrical conductors for a distance of about 80 feet between the new tubular steel pole and the substation. Construction activities are scheduled to begin in mid-May, 2006, or as soon as possible thereafter, and project completion is scheduled for late May or early June, 2006, or as soon as possible thereafter.

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." The following measures are proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low cost" measures will be employed.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- "the minor relocation of power line facilities, or the intersetting of additional supporting structures between existing supporting structures...."

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.1 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
