Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

The Company has been requested by a developer, Granville Homes, Inc., to relocate a portion of the Sanger-Malaga 115 Kilovolt Power Line and a portion of the Sanger-California #2 70 Kilovolt Power Line in conjunction with the development of new subdivision tracts near Church Avenue between Sunnyside and Fowler Avenues in the City of Fresno. The two existing separate power lines will be combined into one double-circuit power line located in the median of the future Church Avenue alignment. This relocation will allow development of the subdivision tracts along with the construction of Church Avenue. PG&E will relocate approximately 2600 feet of the Sanger-Malaga power line approximately 180 feet to the north to the new alignment. The existing poles will remain to support the existing distribution underbuild until the distribution is undergrounded in conjunction with the development. An eight-pole segment of the existing Sanger-California #2 power line will be removed and relocated approximately 15 feet to the north to the new alignment. The double-circuit line will be supported by 5 new tubular steel poles approximately 95 to 100 feet tall and 4 new wood poles

approximately 85 to 90 feet tall. Work will commence in April, 2006, or as soon thereafter as possible, and will be completed by June, 2006, or as soon thereafter as possible.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsections B.1.g, which exempt the following:

- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement.

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs). The following measures are proposed for this project:

- Two of the four new wood poles will be raised ten feet taller than otherwise required to reduce public exposure to EMF at ground level.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

### **Protests**

## NOTICE OF PROPOSED CONSTRUCTION

**PROJECT NAME:** Sanger-Malaga 115 Kilovolt Power Line & Sanger-California #2 70 Kilovolt Power Line Relocation, City of Fresno  
**ADVICE LETTER NUMBER:** 2799-E

**Proposed Project:** Pacific Gas and Electric Company (PG&E) has been requested by a developer, Granville Homes, Inc., to relocate a portion of the Sanger-Malaga 115 Kilovolt Power Line and a portion of the Sanger-California #2 70 Kilovolt Power Line in conjunction with the development of new subdivision tracts near Church Avenue between Sunnyside and Fowler Avenues in the City of Fresno. The two existing separate power lines will be combined into one double-circuit power line located in the median of the future Church Avenue alignment. This relocation will allow development of the subdivision tracts along with the construction of Church Avenue. PG&E will relocate approximately 2600 feet of the Sanger-Malaga power line approximately 180 feet to the north to the new alignment. The existing poles will remain to support the existing distribution underbuild until the distribution is undergrounded in conjunction with the development. An eight-pole segment of the existing Sanger-California #2 power line will be removed and relocated approximately 15 feet to the north to the new alignment. The double-circuit line will be supported by 5 new tubular steel poles approximately 95 to 100 feet tall and 4 new wood poles approximately 85 to 90 feet tall. Work will commence in April, 2006, or as soon thereafter as possible, and will be completed by June, 2006, or as soon thereafter as possible.

**Electric and Magnetic Fields (EMF):** Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." The following measure is proposed for this project:

- Two of the four wood poles will be raised ten feet taller than otherwise required to reduce public exposure to EMF at ground level.

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- g) power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- c.b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- e.c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
- 5.4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
