**Subject: Submits Notice of Construction, Pursuant to General Order  
131-D, for the Relocation of King City-Coburn #2 60kV Power  
Line in the City of King City, County of Monterey**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

The Company has been requested by Woodman Development Company, Inc., to relocate a portion of the King City-Coburn #2 60 Kilovolt Power Line in conjunction with the development of a new subdivision tract near Spreckles Road northwesterly of San Antonio Drive in the City of King City, Monterey County. This relocation will allow development of the subdivision tract along with the improvement of Spreckles Road. PG&E will remove seven existing wood poles located within the franchise and install eight new light duty steel poles approximately 25 to 30 feet taller within a new franchise position along Spreckles Road. The new poles will be taller to accommodate new street lights and EMF mitigation. Work will commence in May, 2006, or as soon thereafter as possible, and will be completed by June, 2006, or as soon thereafter as possible.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsections B.1.g, which exempts the following:

- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement.

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs). The following measures are proposed for this project:

- The eight new poles will be raised ten feet taller than otherwise required to reduce public exposure to EMF at ground level.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

### **Protests**

**PROJECT NAME:** King City-Coburn #2 60 Kilovolt Power Line Relocation, City of King City, County of Monterey

**Proposed Project:** Pacific Gas and Electric Company (PG&E) has been requested by Woodman Development Company, Inc., to relocate a portion of the King City-Coburn #2 60 Kilovolt Power Line in conjunction with the development of a new subdivision tract near Spreckles Road northwesterly of San Antonio Drive in the City of King City, Monterey County. This relocation will allow development of the subdivision tract along with the improvement of Spreckles Road. PG&E will remove seven existing wood poles located within the franchise and install eight new light duty steel poles approximately 25 to 30 feet taller within a new franchise position along Spreckles Road. The new poles will be taller to accommodate new street lights and EMF mitigation. Work will commence in May, 2006, or as soon thereafter as possible, and will be completed by June, 2006, or as soon thereafter as possible.

**Electric and Magnetic Fields (EMF):** Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." The following measure is proposed for this project:

- The eight new poles will be raised ten feet taller than otherwise required to reduce public exposure to EMF at ground level.

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- g) power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- c.b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- e.c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
- 5.4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
