**Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Relocation of Coalinga-San Miguel 70 Kilovolt Power Line Relocation, City of Coalinga, County of Fresno**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

The Company has been requested by Hofmann Land Development Company to relocate a portion of the Coalinga-San Miguel 70 Kilovolt Power Line in conjunction with the development of subdivision tract 5451 south of the intersection of Merced Avenue and Jayne Avenue (also known as Polk Avenue at this location) in the City of Coalinga, Fresno County. This relocation will allow development of the subdivision tract along with the improvement of the intersection of Jayne Avenue and Merced Avenue. The Company will remove 11 existing 55 foot tall wood poles located diagonally within the proposed subdivision and install 13 new wood poles approximately 10 feet taller within a franchise position along Merced Avenue and Lucille Avenue. In addition, the Company will replace two existing wood poles along Merced Avenue near Jayne

Avenue with new wood poles approximately 25 feet taller and 50 feet east. One pole along Jayne Avenue near Merced Avenue will be replaced with a wood pole approximately 15 feet taller. All of the poles for this job will be taller to accommodate proposed street and signal lights, and to meet current design standards. Work may commence as early as July, 2006, or as soon thereafter as possible, and should be completed by September, 2006, or as soon thereafter as possible.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsections B.1.g, which exempt the following:

- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement.

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs). The following measures are proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low cost" measures will be employed.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

### **Protests**

## NOTICE OF PROPOSED CONSTRUCTION

**PROJECT NAME: Coalinga-San Miguel 70 Kilovolt Power Line Relocation, City of Coalinga, County of Fresno**  
**ADVICE LETTER NUMBER: 2833-E**

**Proposed Project:** Pacific Gas and Electric Company (PG&E) has been requested by Hofmann Land Development Company to relocate a portion of the Coalinga-San Miguel 70 Kilovolt Power Line in conjunction with the development of subdivision tract 5451 south of the intersection of Merced Avenue and Jayne Avenue (also known as Polk Avenue at this location) in the City of Coalinga, Fresno County. This relocation will allow development of the subdivision tract along with the improvement of the intersection of Jayne Avenue and Merced Avenue. PG&E will remove eleven existing 55 foot tall wood poles located diagonally within the proposed subdivision and install thirteen new wood poles approximately 10 feet taller within a franchise position along Merced Avenue and Lucille Avenue. In addition, PG&E will replace two existing wood poles along Merced Avenue near Jayne Avenue with new wood poles approximately 25 feet taller and 50 feet east. One pole along Jayne Avenue near Merced Avenue will be replaced with a wood pole approximately 15 feet taller. All of the poles for this job will be taller to accommodate proposed street and signal lights, and to meet current design standards. Work may commence as early as July, 2006, or as soon thereafter as possible, and should be completed by September, 2006, or as soon thereafter as possible.

**Electric and Magnetic Fields (EMF):** Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." The following measure is proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low cost" measures will be employed.

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- g) power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
