Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of the Ignacio-Bolinas #1 & #2 60kV Pole Replacement, Marin County

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

As part of ongoing maintenance efforts, the Company is proposing to replace 32 wooden poles with a combination of steel poles and wooden poles along a 24-mile section of its Ignacio-Bolinas #1 and #2 60kV transmission lines. The project is located in rural and pasture land in Marin County between Novato and Bolinas. The new poles will be up to approximately 5 to 10 feet higher than the existing poles.

Construction is expected to begin July 26, 2006, or as soon possible thereafter, and to be completed by December 31, 2007, or as soon as possible thereafter.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1 which exempts, "the replacement of existing power line facilities or supporting structures with equivalent facilities or structures", and "Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts."

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs). The following measures are proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low cost" measures will be employed.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Ignacio-Bolinas #1 & #2 60kV Pole Replacement, Marin County
ADVICE LETTER NUMBER: 2845-E

Proposed Project: As part of ongoing maintenance efforts, Pacific Gas & Electric is proposing to replace 32 wooden poles with a combination of steel poles and wooden poles along a 24-mile section of its Ignacio-Bolinas #1 and #2 60kV transmission lines. The project is located in rural and pasture land in Marin County between Novato and Bolinas. The new poles will be up to approximately 5 to 10 feet higher than the existing poles. Construction is expected to begin July 26, 2006, or as soon as possible thereafter, and to be completed by December 31, 2007, or as soon as possible thereafter.

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." The following measure(s) is proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low cost" measures will be employed.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or the cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- b. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
