**Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of the Mt. Quarries 60kV Reconductoring Project, Placer and El Dorado Counties**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

The Company is proposing to replace existing wires with new wires on (reconductor) the Mt. Quarries 60kV Tap Line in the county of Placer and the county of El Dorado, California. This project is needed to provide reliable electric transmission service to customers in the area. The reconductoring will occur between Mt. Quarries Substation in El Dorado County and the tap line connection point on Auburn Ravine Road in Placer County, a distance of approximately 2.5 miles. The project will consist of replacing 27 wooden poles with a combination of 18 tubular steel poles (TSP's) and 9 wooden poles along the existing 2.5 mile tap line. The existing wooden fuse pole will be replaced with a TSP switch pole at the point of connection on Auburn Ravine Road. The new poles will be approximately 5 to 10 feet higher than the existing poles.

Construction is expected to begin in August, 2006, or as soon possible thereafter, and to be completed by May, 2007, or as soon as possible thereafter.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1 which exempts, "the replacement of existing power line facilities or supporting structures with equivalent facilities or structures," and "Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts."

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs). The following measures are proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low cost" measures will be employed.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

### **Protests**

## NOTICE OF PROPOSED CONSTRUCTION

**PROJECT NAME: MT. QUARRIES 60KV RECONDUCTORING PROJECT, COUNTY OF PLACER AND COUNTY OF EL DORADO**  
**ADVICE LETTER NUMBER: 2854-E**

**Proposed Project:** Pacific Gas and Electric Company proposes to replace existing wires with new wires on (reconductor) the Mt. Quarries 60kV Tap Line in the county of Placer and the county of El Dorado, California. This project is needed to provide reliable electric transmission service to customers in the area. The reconductoring will occur between Mt. Quarries Substation in El Dorado County and the tap line connection point on Auburn Ravine Road in Placer County, a distance of approximately 3.5 miles. The project will consist of replacing 27 wooden poles with a combination of 18 tubular steel poles (TSP's) and 9 wooden poles along the existing 3.5 mile tap line. The existing wooden fuse pole will be replaced with a TSP switch pole at the point of connection on Auburn Ravine Road. The new poles will be approximately 5 to 10 feet higher than the existing poles. Construction is expected to begin in August, 2006, or as soon as possible thereafter, and the new facilities are planned to be in operation in May, 2007, or as soon as possible thereafter.

**Electric and Magnetic Fields (EMF):** Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." The following measure(s) is proposed for this project:

- Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low cost" measures will be employed.

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or the cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- b. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
