Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

The Company has been requested by KB Homes to relocate a portion of the Sanger-California #2 70 Kilovolt Power Line in conjunction with the development of a new subdivision tract near Church Avenue east of Peach Avenue in the City of Fresno. This relocation will allow development of the subdivision tract along with the improvement of Church and Peach Avenues. The Company will relocate and re-span a 3500-foot portion of the power line, replacing 16 existing wood poles with a total of 14 new wood poles. Three of the new poles will be relocated approximately 15 to 25 feet to the north to a franchise location along Church Avenue. The remaining 11 new poles will be placed in the existing alignment (in franchise). The new poles will be approximately 5 feet taller to accommodate new street lights and EMF mitigation. Work will commence in

February, 2007, or as soon thereafter as possible, and will be completed by April, 2007, or as soon thereafter as possible.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsections B.1.b. and g, which exempt the following:

- b) The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g) Power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement.

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs). The following measures are proposed for this project:

- The fourteen poles will be raised five feet taller than otherwise required to reduce public exposure to EMF at ground level.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Proposed Project: Pacific Gas and Electric Company (PG&E) has been requested by KB Homes to relocate a portion of the Sanger-California #2 70 Kilovolt Power Line in conjunction with the development of a new subdivision tract near Church Avenue east of Peach Avenue in the City of Fresno. This relocation will allow development of the subdivision tract along with the improvement of Church and Peach Avenues. PG&E will relocate and re-span a 3500-foot portion of the power line, replacing 16 existing wood poles with a total of 14 new wood poles. Three of the new poles will be relocated approximately 15 to 25 feet to the north to a franchise location along Church Avenue. The remaining 11 new poles will be placed in the existing alignment (in franchise). The new poles will be approximately 5 feet taller to accommodate new street lights and EMF mitigation. Work will commence in February, 2007, or as soon thereafter as possible, and will be completed by April, 2007, or as soon thereafter as possible.

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." The following measure is proposed for this project:

- The fourteen poles will be raised five feet taller than otherwise required to reduce public exposure to EMF at ground level.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- b) The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g) Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- c.b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- e.c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
- 5.4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
