Line Relocation, City of Bakersfield, County of Kern**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

The Company has been requested by Lennar Homes of California, Inc., in conjunction with the development of subdivision tract 6333, to relocate two existing wood poles which will affect approximately 1,350 feet of the Kern-Old River #2 70 Kilovolt Power Line. This relocation will allow for improvements to be made on South Union Avenue and at the intersection of South Union Avenue and Panama Lane, in the City of Bakersfield, Kern County. One existing 75 foot tall wood pole, currently located at the southeast corner of the intersection of South Union Avenue and Panama Lane, will be moved approximately 49 feet southerly and approximately 55 feet easterly, and will be replaced with a new 85 foot tall wood pole. The other existing 70 foot wood pole located approximately 327 feet south of the intersection (on the east side of South Union Avenue) will

be moving approximately 13 feet easterly and will be replaced with a new 75 foot tall wood pole. The Company will also replace an existing 35 foot tall wood pole, located on the south side of Panama Lane and approximately 100 feet west of the intersection, with a new 70 foot tall wood pole. All of the poles for this job will be taller to accommodate the street and signal lights, and to meet current design standards. In addition, the Company will install three new 35 foot tall wood stub poles on the west side of South Union Avenue, with span guy wires crossing South Union Avenue and attached to the stub poles then anchored with guy wires into the ground. Work may commence as early as March, 2007, or as soon thereafter as possible, and should be completed by June, 2007, or as soon thereafter as possible.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsections B.1.c, which exempts the following:

- c) The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Kern - Old River #2 70 Kilovolt Power Line Relocation, City of Bakersfield, County of Kern
ADVICE LETTER NUMBER: 2973-E

Proposed Project: Pacific Gas and Electric Company (PG&E) has been requested by Lennar Homes of California, Inc., in conjunction with the development of subdivision tract 6333, to relocate two existing wood poles which will affect approximately 1,350 feet of the Kern-Old River #2 70 Kilovolt Power Line. This relocation will allow for improvements to be made on South Union Avenue and at the intersection of South Union Avenue and Panama Lane, in the City of Bakersfield, Kern County. One existing 75 foot tall wood pole, currently located at the southeast corner of the intersection of South Union Avenue and Panama Lane, will be moved approximately 49 feet southerly and approximately 55 feet easterly, and will be replaced with a new 85 foot tall wood pole. The other existing 70 foot wood pole located approximately 327 feet south of the intersection (on the east side of South Union Avenue) will be moving approximately 13 feet easterly and will be replaced with a new 75 foot tall wood pole. PG&E will also replace an existing 35 foot tall wood pole, located on the south side of Panama Lane and approximately 100 feet west of the intersection, with a new 70 foot tall wood pole. All of the poles for this job will be taller to accommodate the street and signal lights, and to meet current design standards. In addition, PG&E will install three new 35 foot tall wood stub poles on the west side of South Union Avenue, with span guy wires crossing South Union Avenue and attached to the stub poles then anchored with guy wires into the ground. Work may commence as early as March, 2007, or as soon thereafter as possible, and should be completed by June, 2007, or as soon thereafter as possible.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- c) [The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.](#)

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
