Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of the Herdlyn-Balfour 60kV Pole Relocation in the City of Tracy

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

The Company has been requested by Shea Homes, developer of Mountain House Development, to relocate approximately 18,000 feet of its Herdlyn-Balfour 60kV power line (approximately 68 poles) roughly 3,400 feet south from its original location in the City of Tracy in order to accommodate the new development. The relocation will leave the existing line at the Alameda County line near Lindemann Road, cross open land for approximately 1 mile to the franchise area in Byron Highway, proceed east along Byron Highway through Tracy approximately 2.7 miles to Wicklund Street, then north on Wicklund Street to Wicklund Substation where it will meet the existing line. The new wood poles may be somewhat taller than existing poles consistent with current CPUC standards, depending on final engineering. The portion of the line to be relocated currently runs along undeveloped and agricultural land north of Byron Highway. Construction is expected to begin in March, 2007, or as soon as possible thereafter, and to be completed by December 31, 2008, or as soon as possible thereafter.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1 which exempts, Power lines or substations to be relocated

or constructed that have undergone environmental review pursuant to CEQA as part of a larger project, and for which the final CEQA document finds no significant unavoidable environmental impacts caused by the proposed line or substation. Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies for which a final CEQA document finds no significant unavoidable environmental impacts. In addition, the Final Environmental Impact Report for the Mountain House Master Plan and Specific Plan (State Clearinghouse No. 90020776), adopted September 1994, as updated by the Mountain House Specific Plan II Initial Study (December 2004), identified no significant unavoidable environmental impacts caused by the power line relocation.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Proposed Project: Pacific Gas and Electric Company (PG&E) has been requested by Shea Homes, developer of Mountain House Development, to relocate approximately 18,000 feet of its Herdlyn-Balfour 60kV power line (approximately 68 poles) roughly 3,400 feet south from its original location in the City of Tracy in order to accommodate the new development. The relocation will leave the existing line at the Alameda County line near Lindemann Road, cross open land for approximately 1 mile to the franchise area in Byron Highway, proceed east along Byron Highway through Tracy approximately 2.7 miles to Wicklund Street, then north on Wicklund Street to Wicklund Substation where it will meet the existing line. The new wood poles may be somewhat taller than existing poles consistent with current CPUC standards, depending on final engineering. The portion of the line to be relocated currently runs along undeveloped and agricultural land north of Byron Highway. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- Power lines or substations to be relocated or constructed that have undergone environmental review pursuant to CEQA as part of a larger project, and for which the final CEQA document finds no significant unavoidable environmental impacts caused by the proposed line or substation.
- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies for which a final CEQA document finds no significant unavoidable environmental impacts.

The Final Environmental Impact Report for the Mountain House Master Plan and Specific Plan (State Clearinghouse No. 90020776) , adopted September 1994, as updated by the Mountain House Specific Plan II Initial Study (December 2004), identified no significant unavoidable environmental impacts caused by the power line relocation.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- c.b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- d.c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
- 5.4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
