Avenue between 17th Avenue and 18th Avenue, County of Kings**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

The Company has been requested by the County of Kings to relocate approximately 7,830 feet of the Henrietta-Kingsburg 115 kilovolt power line in conjunction with the County's road widening project on Jersey Avenue from approximately 1,250 feet east of 17th Avenue to approximately 1,300 feet west of 18th Avenue south of the City of Lemoore. To accommodate the County's project, PG&E will need to replace approximately 26 existing wood poles with approximately 27 new wood poles that will be approximately 5 to 15 feet taller than the existing wood poles to reduce EMF and meet ground clearance requirements. PG&E is proposing to replace the easterly 6 wood poles currently on the north side of Jersey Avenue with approximately 6 new wood poles approximately 20 to 30 feet to the north of the existing poles. The remaining 20 wood poles located on the south side of Jersey Avenue will be replaced with approximately 21 new wood poles approximately 30 to 50 feet to the south of the existing wood poles. In addition, PG&E will install approximately 3 new 40-foot-tall wood stub poles with guy appurtenances. The stub pole and guy will consist of a span guy crossing Jersey Avenue and attached to the stub pole then anchored with a guy into the ground. All of

the new pole locations will be within the County's Jersey Avenue road right-of-way. The work is scheduled to commence in April, 2007, or as soon thereafter as possible, and to be completed by October, 2007, or as soon thereafter as possible.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsections B.1.g, which exempt the following:

- g) Power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement.

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs). The following measures are proposed for this project:

- The 27 new wood poles will be raised ten feet taller than otherwise required to reduce public exposure to EMF at ground level.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Henrietta-Kingsburg 115 Kilovolt Power Line Relocation (a.k.a Henrietta-GWF 115 Kilovolt Power Line) located on Jersey Avenue between 17th Avenue and 18th Avenue, County of Kings
ADVICE LETTER NUMBER: 3000-E

Proposed Project: Pacific Gas and Electric Company (PG&E) has been requested by the County of Kings to relocate approximately 7,830 feet of the Henrietta-Kingsburg 115 kilovolt power line in conjunction with the County's road widening project on Jersey Avenue from approximately 1,250 feet east of 17th Avenue to approximately 1,300 feet west of 18th Avenue south of the City of Lemoore. To accommodate the County's project, PG&E will need to replace approximately 26 existing wood poles with approximately 27 new wood poles that will be approximately 5 to 15 feet taller than the existing wood poles to reduce EMF and meet ground clearance requirements. PG&E is proposing to replace the easterly 6 wood poles currently on the north side of Jersey Avenue with approximately 6 new wood poles approximately 20 to 30 feet to the north of the existing poles. The remaining 20 wood poles located on the south side of Jersey Avenue will be replaced with approximately 21 new wood poles approximately 30 to 50 feet to the south of the existing wood poles. In addition, PG&E will install approximately 3 new 40-foot-tall wood stub poles with guy appurtenances. The stub pole and guy will consist of a span guy crossing Jersey Avenue and attached to the stub pole then anchored with a guy into the ground. All of the new pole locations will be within the County's Jersey Avenue road right-of-way. The work is scheduled to commence in April, 2007, or as soon thereafter as possible, and to be completed by October, 2007, or as soon thereafter as possible.

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 06-01-042 and Pacific Gas and Electric Company's "EMF Design Guidelines for Electrical Facilities." The following measures are proposed for this project:

- The 27 new wood poles will be raised ten feet taller than otherwise required to reduce public exposure to EMF at ground level.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- g) Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
