**Subject: Submits Notice of Construction, Pursuant to General Order 131-D,
for the Replacement of 57 Poles on the Valley Springs #1 Line in
the County of Calaveras**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

The Company proposes to replace existing distribution wires with new wires (reconductor) that are located as underbuild on a 2.5-mile segment of the Valley Springs #1 60kV power line in Calaveras County, California. The project will require replacing 57 wood poles with approximately 5 to 10 feet taller wood poles in the existing alignment between Olive Branch Drive, north of Highway 26, and the intersection of Baldwin Street and Highway 26. This project is needed to provide reliable electric distribution service to customers in the area. Construction is scheduled to begin in April, 2007, or as soon thereafter as possible, with completion in June, 2007, or as soon as possible after construction begins.

- This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1.b and B.1.g, which exempts, “The replacement of existing power line facilities or supporting structures with equivalent facilities or structures” and “Power line facilities or substations to be located in an existing franchise, road widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.”

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: VALLEY SPRINGS #1 60kV POLE REPLACEMENT PROJECT, COUNTY OF CALAVERAS
ADVICE LETTER NUMBER: 3005-E

Proposed Project: Pacific Gas and Electric Company proposes to replace existing distribution wires with new wires (reconductor) that are located as underbuild on a 2.5-mile segment of the Valley Springs #1 60kV power line in Calaveras County, California. The project will require replacing 57 wood poles with approximately 5 to 10 feet taller wood poles in the existing alignment between Olive Branch Drive, north of Highway 26, and the intersection of Baldwin Street and Highway 26. This project is needed to provide reliable electric distribution service to customers in the area. Construction is scheduled to begin in April, 2007, or as soon thereafter as possible, with completion in June, 2007, or as soon as possible after construction begins.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- Power line facilities or substations to be located in an existing franchise, road widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
