Subject: Pilot Program to Streamline Line Extension Procedures

Purpose

Pacific Gas and Electric Company seeks to notify the Commission of a pilot program under which PG&E plans to modify its internal business procedures to allow less restrictive payment arrangements for new individual residential services. The purpose of the pilot is to help PG&E reduce the cycle time for connecting new customers and improve overall customer satisfaction with the new customer connection process.

Background

Under PG&E's Gas and Electric Rules 16.E.4, PG&E collects full payment of non-refundable costs from new service applicants before commencing construction on facilities that extend from PG&E's distribution system to the service delivery point. PG&E's experience has shown that there is minimal financial risk associated with new individual residential jobs under Rule 16, and the time it takes to bill and process payment adds approximately 37 days to the cycle time for connecting new customers. Of the 8,000 jobs of this type completed in 2006, the customer contribution was less than \$1,000 in 50 percent of the jobs, and less than \$3,100 in 75 percent of the jobs.

Pilot Program

To streamline the process for connecting new customers and improve customer satisfaction, PG&E plans to implement a new, less restrictive process for individual residential services that will allow construction to commence upon receipt of the Applicant's commitment to pay nonrefundable costs. However, PG&E will not

install the meter (the last step before energizing the service) until payment has been received.

PG&E plans to test this new approach in Bakersfield, San Jose, and San Rafael. PG&E will evaluate the effectiveness of the new business processes and will get feedback from applicants of completed new services. If the pilot is successful, PG&E plans to expand the program system-wide for all individual residential customers.

Protests

Pursuant to section V.B of General Order 96-A, PG&E requests an expedited protest period and review period to allow the pilot program commence on March 26, 2007. The pilot program will benefit customers by providing less restrictive payment arrangements, allowing PG&E to reduce the time to connect new customers. PG&E is not requesting any changes to its tariff sheets, and there will be no increases in rates or charges. Anyone wishing to protest this filing may do so by letter sent via U.S. mail, by facsimile or electronically, any of which must be received no later than March 21, 2007, with replies to protests due March 23, 2007. 
