Joaquin**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

In order to accommodate the proposed Rite Aid construction project in the City of Tracy, the Company has been requested by Halferty Development Company to relocate a pole on the existing Carbona #1 60kV power lines from its current position in front of the proposed Rite Aid on MacArthur Drive, north of West Valpico Road, to a new location in the same alignment 43 feet to the north. The new pole will replace an existing distribution pole near 2675 MacArthur Drive. Construction is scheduled to begin in May, 2007, or as soon thereafter as possible, with completion in approximately one week or as soon as possible after construction begins.

- This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1.b, which exempts, "The replacement of existing power line facilities or supporting structures with equivalent facilities or structures," and Subsection B.1.g, which exempts, "Power line facilities or substations to be located in an existing franchise, road widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts."

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

## NOTICE OF PROPOSED CONSTRUCTION

**PROJECT NAME: CARBONA #1 60kV TAP POLE RELOCATION, CITY OF TRACY**  
**ADVICE LETTER NUMBER: 3026-E**

**Proposed Project:** In order to accommodate the proposed Rite Aid construction project in the City of Tracy, PG&E has been requested by Halferty Development Company to relocate a pole on the existing Carbona #1 60kV power lines from its current position in front of the proposed Rite Aid on MacArthur Drive, north of West Valpico Road, to a new location in the same alignment 43 feet to the north. The new pole will replace an existing distribution pole near 2675 MacArthur Drive. Construction is scheduled to begin in May, 2007, or as soon thereafter as possible, with completion in approximately one week or as soon as possible after construction begins.

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- Power line facilities or substations to be located in an existing franchise, road widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
