Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection A, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

Due to increased electrical demand within the southern portion of the City of Napa, the Company proposes to replace distribution wires located under the existing Tulucay-Napa No. 2 60kV power line. As part of the project, the Company will replace 13 existing wood poles with 13 new wood poles of roughly similar height that support both distribution (low-voltage) and power (higher voltage) lines. The existing power line begins at Basalt Substation, runs in a westerly direction approximately 450 feet crossing Highway 121, and then runs within Highway 121 along the westerly boundary line in a northerly direction approximately 6700 feet to West Imola Avenue. Construction activities are tentatively scheduled to begin June 1, 2007, or as soon as possible thereafter, and project completion is scheduled in late June, 2007, or as soon as possible thereafter.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, B, which states that a Permit to Construct is not required for:

- “The replacement of existing power line facilities or supporting structures with equivalent facilities or structures,” and
- “Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.”

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

## NOTICE OF PROPOSED CONSTRUCTION

**PROJECT NAME:** Tulucay-Napa No. 2, 60kV Power Line Pole Replacement, City of Napa  
**ADVICE LETTER NUMBER:** 3032-E

**Proposed Project:** Due to increased electrical demand within the southern portion of the City of Napa, Pacific Gas and Electric Company (PG&E) proposes to replace distribution wires located under the existing Tulucay-Napa No. 2 60kV power line. As part of the project, PG&E will replace 13 existing wood poles with 13 new wood poles of roughly similar height that support both distribution (low-voltage) and power (higher voltage) lines. The existing power line begins at Basalt Substation, runs in a westerly direction approximately 450 feet crossing Highway 121, and then runs within Highway 121 along the westerly boundary line in a northerly direction approximately 6700 feet to West Imola Avenue. Construction activities are tentatively scheduled to begin June 1, 2007, or as soon as possible thereafter, and project completion is scheduled in late June, 2007, or as soon as possible thereafter.

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemptions:

- (b) The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- (g) Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.1 of General Order 131-D exist;

- There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- Your name, mailing address and daytime telephone number.
- Reference to the CPUC Advice Letter Number and Project Name.
- A clear description of the reason for the protest.
- Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
