Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

To accommodate a Cal Trans road widening project at Highway 29 and the entrance to Hidden Valley Lake subdivision in Lake County, the Company proposes to relocate four existing 60 Kilovolt (kV) wood poles on the Clear Lake-Eagle Rock 60 kV power line. Beginning at the northwesterly corner of the Spruce Grove Exit and the Highway 29 intersection, an existing pole approximately 55 feet tall will be replaced with a new pole approximately 65 feet tall located approximately 5 feet south of its original location. South of the entrance to Hidden Valley Lake, off of Highway 29, the approximately 60 feet tall existing pole will be moved from the east to the west side of Highway 29 and replaced with a new pole approximately 65 feet tall. Moving one span to the south (approximately 321 feet), an existing pole approximately 50 feet tall will be moved from the east to the west side of Highway 29 and replaced with a pole approximately 70 feet tall. Moving again one span to the south, another pole approximately 50 feet tall will be replaced with a pole approximately 70 feet tall just north of its original location. These new wood poles will support the existing distribution and existing transmission lines. Construction activities are tentatively scheduled to begin September, 2007, or as soon as possible thereafter, and project completion is scheduled October, 2007, or as soon as possible thereafter.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1 which exempts the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Clear Lake-Eagle Rock 60 kV Pole Relocation, Hidden Valley Lake
ADVICE LETTER NUMBER: 3083-E

Proposed Project: To accommodate a Cal Trans road widening project at Highway 29 and the entrance to Hidden Valley Lake subdivision in Lake County, Pacific Gas and Electric Company (PG&E) proposes to relocate four existing 60 Kilovolt (kV) wood poles on the Clear Lake-Eagle Rock 60 kV power line. Beginning at the northwesterly corner of the Spruce Grove Exit and the Highway 29 intersection, an existing pole approximately 55 feet tall will be replaced with a new pole approximately 65 feet tall located approximately 5 feet south of its original location. South of the entrance to Hidden Valley Lake, off of Highway 29, the approximately 60 feet tall existing pole will be moved from the east to the west side of Highway 29 and replaced with a new pole approximately 65 feet tall. Moving one span to the south (approximately 321 feet), an existing pole approximately 50 feet tall will be moved from the east to the west side of Highway 29 and replaced with a pole approximately 70 feet tall. Moving again one span to the south, another pole approximately 50 feet tall will be replaced with a pole approximately 70 feet tall just north of its original location. These new wood poles will support the existing distribution and existing transmission lines. Construction activities are tentatively scheduled to begin September, 2007, or as soon as possible thereafter, and project completion is scheduled October, 2007, or as soon as possible thereafter.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- (c) The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
