Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

In order to accommodate Mossdale Associates' proposed sand quarry expansion project in the County of San Joaquin, the Company has been requested to relocate towers on the existing Vierra-Tracy-Kasson 115 kV power line located entirely on Mossdale Associates' quarry property between the San Joaquin River and Interstate 5. The Company will remove two lattice steel towers from their present location on the quarry property just southwest of the San Joaquin River, and replace them with one new lattice steel tower approximately 160' tall (approximately 43 feet taller than existing) in the same alignment (existing public utility easement) 225 feet to the southwest of the first tower. A third lattice steel tower will be relocated from its present location approximately 2,100 feet southwest of the San Joaquin River to a new location in the same alignment (existing public utility easement) 50 feet to the northeast, requiring a new lattice steel tower approximately 160 feet tall (approximately 90 feet taller than existing). The taller poles are required because, with one less tower, more height is needed to ensure conductor to ground clearance for the increased length of the spans. Construction is scheduled to begin in September, 2007, or as soon thereafter as

possible, with completion in approximately four weeks or as soon as possible after construction begins.

- This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1.g, which exempts, "Power line facilities or substations to be located in an existing franchise, road widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts."

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

## NOTICE OF PROPOSED CONSTRUCTION

**PROJECT NAME: VIERRA-TRACY-KASSON 115 KV TOWER RELOCATION (SAN JOAQUIN COUNTY)**  
**ADVICE LETTER NUMBER: 3105-E**

**Proposed Project:** In order to accommodate Mossdale Associates' proposed sand quarry expansion project in the County of San Joaquin, PG&E has been requested to relocate towers on the existing Vierra-Tracy-Kasson 115 kV power line located entirely on Mossdale Associates' quarry property between the San Joaquin River and Interstate 5. PG&E will remove two lattice steel towers from their present location on the quarry property just southwest of the San Joaquin River, and replace them with one new lattice steel tower approximately 160' tall (approximately 43 feet taller than existing) in the same alignment (existing public utility easement) 225 feet to the southwest of the first tower. A third lattice steel tower will be relocated from its present location approximately 2,100 feet southwest of the San Joaquin River to a new location in the same alignment (existing public utility easement) 50 feet to the northeast, requiring a new lattice steel tower approximately 160 feet tall (approximately 90 feet taller than existing). The taller towers are required because, with one less tower, more height is needed to ensure conductor to ground clearance for the increased length of the spans. Construction is scheduled to begin in September, 2007, or as soon thereafter as possible, with completion in approximately four weeks or as soon as possible after construction begins.

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
