**Subject: Notice of Proposed Construction of Facilities Pursuant to General Order
131-D, Ignacio-San Rafael #3, Relocate Facilities in San Rafael**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

To accommodate the road-widening of Highway 101 in San Rafael by California State Department of Transportation (Cal Trans), the Company proposes to replace and relocate two segments, spanning a total of approximately 1990 feet on the existing Ignacio-San Rafael 115 kV Power Line. Along each segment, two existing wood poles 65 to 75 feet tall will be replaced with two tubular steel poles approximately 10 to 20 feet taller to allow sufficient distance between the ground and conductors on the sloping ground. The first segment of the proposed relocation begins at an existing pole located approximately 120 feet southerly of Lincoln Avenue and the Highway 101 onramp and then runs northeasterly approximately 640 feet, along the westerly boundary line of Highway 101 to an existing pole approximately 240 feet northwesterly of the Lincoln Avenue and Fair Drive intersection. The second segment begins approximately 960 feet southerly of the Pilgrim Way and Merrydale Road intersection on the westerly boundary line of Pilgrim Way and then runs approximately 695 feet southeasterly along the westerly boundary line of Highway 101 to an existing pole approximately 220 feet

northerly of Lincoln Avenue (Los Ranchitos Road) as it begins to veer westerly at a downward slope. Construction is proposed to begin October 28, 2007, or as soon as possible thereafter, and project completion is scheduled for May, 2008, or as soon as possible thereafter.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, B.1, which states that a Permit to Construct is not required for:

- “The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.”

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Ignacio-San Rafael #3 Relocate Facilities in San Rafael
ADVICE LETTER NUMBER: 3113-E

Proposed Project: To accommodate the road-widening of Highway 101 in San Rafael by California State Department of Transportation (Cal Trans), Pacific Gas and Electric Company proposes to replace and relocate two segments, spanning a total of approximately 1990 feet on the existing Ignacio-San Rafael 115 kV Power Line. Along each segment, two existing wood poles 65 to 75 feet tall will be replaced with two tubular steel poles approximately 10 to 20 feet taller to allow sufficient distance between the ground and conductors on the sloping ground. The first segment of the proposed relocation begins at an existing pole located approximately 120 feet southerly of Lincoln Avenue and the Highway 101 onramp and then runs northeasterly approximately 640 feet, along the westerly boundary line of Highway 101 to an existing pole approximately 240 feet northwesterly of the Lincoln Avenue and Fair Drive intersection. The second segment begins approximately 960 feet southerly of the Pilgrim Way and Merrydale Road intersection on the westerly boundary line of Pilgrim Way and then runs approximately 695 feet southeasterly along the westerly boundary line of Highway 101 to an existing pole approximately 220 feet northerly of Lincoln Avenue (Los Ranchitos Road) as it begins to veer westerly at a downward slope. Construction is proposed to begin October 28, 2007, or as soon as possible thereafter, and project completion is scheduled for May, 2008, or as soon as possible thereafter.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- (c) "The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures."

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
