**Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for  
the Construction of Ox Mountain 60 kV Power Line Interconnection  
Project in the County of San Mateo**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

The Company has been requested by Ameresco to connect the proposed Ox Mountain Landfill Gas to Energy (LFGTE) generator tie line to the existing PG&E Hillsdale Junction-Half Moon Bay 60 kV power line. Completion of this project will allow power generated at Ox Mountain to be transmitted to customers in the Cities of Alameda and Santa Clara. The project, which consists of intersetting an 80 foot wood pole with 2 switches within the Hillsdale Junction-Half Moon Bay 60 kV power line, is located approximately 3000 feet north of Highway 92 and approximately 3 miles northeast of Highway I in Half Moon Bay. The interset pole will support the connection to Ameresco's new 60 kV line and LFGTE generator. Construction of the pole is scheduled to begin in November, 2007, or as soon as possible thereafter, and project completion is scheduled for April, 2008, or as soon as possible thereafter.

CPUC General Order 131-D, Section III, A, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemptions:

- “The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.”
- “Power line facilities or substations to be located in an existing franchise, road widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.”

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs) in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." The following measures are proposed for this project:

Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low cost" measures will be employed.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

## NOTICE OF PROPOSED CONSTRUCTION

**PROJECT NAME:** Ox Mountain Generator 60 kV Power Line Interconnection Project (Half Moon Bay)

**ADVICE LETTER NUMBER:** 3121-E

**Proposed Project:** Pacific Gas and Electric Company (PG&E Co.) has been requested by Ameresco to connect the proposed Ox Mountain Landfill Gas to Energy (LFGTE) generator tie line to the existing PG&E Hillsdale Junction-Half Moon Bay 60 kV power line. Completion of this project will allow power generated at Ox Mountain to be transmitted to customers in the Cities of Alameda and Santa Clara. The project, which consists of intersetting an 80 foot wood pole with 2 switches within the Hillsdale Junction-Half Moon Bay 60 kV power line, is located approximately 3000 feet north of Highway 92 and approximately 3 miles northeast of Highway I in Half Moon Bay. The interset pole will support the connection to Ameresco's new 60 kV line and LFGTE generator. Construction of the pole is scheduled to begin in November, 2007, or as soon as possible thereafter, and project completion is scheduled for April, 2008, or as soon as possible thereafter.

**Electric and Magnetic Fields (EMF):** Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 93-11-013 and Pacific Gas and Electric Company's "EMF Design Guidelines of New Electrical Facilities: Transmission, Substation, and Distribution." Because there are no EMF mitigation measures available on this project that would meet the CPUC's benchmark of 4% or less of the total project cost, no "no cost" or "low cost" measures will be employed.

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. PG&E Co. believes this project qualifies for the following exemptions:

- "The minor relocation of existing power line facilities, or the intersetting of additional supporting structures between existing supporting, up to 2000 feet in length."
- "Power line facilities or substations to be located in an existing franchise, roadwidening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts."

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.1 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
