Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

Pacific Gas and Electric Company (PG&E) plans to replace the existing wires with new wires (reconductor) on a segment of the existing Humboldt-Harris 115 kilovolt (kV) power line in the County of Humboldt. The project begins at the Humboldt Substation located at the east end of Mitchell Heights Road, proceeds approximately 1.1 miles west, and terminates within the Harris Substation located off of Harris Street. 12 poles will be replaced to support the new wires. These new poles will be 5-10 feet taller than existing poles to allow proper wire clearance above the ground. Work is scheduled to begin in August, 2008, or as soon thereafter as possible, and will be completed by October, 2008, or as soon thereafter as possible.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsections B.1.b, and g, which exempts the following:

- b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.

- g) power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Humboldt- Harris 115 KV Reconductoring Project, County of Humboldt

Proposed Project: Pacific Gas and Electric Company (PG&E) plans to replace the existing wires with new wires (reconductor) on a segment of the existing Humboldt-Harris 115 kilovolt (kV) power line in the County of Humboldt. The project begins at the Humboldt Substation located at the east end of Mitchell Heights Road, proceeds approximately 1.1 miles west, and terminates within the Harris Substation located off of Harris Street. 12 poles will be replaced to support the new wires. These new poles will be 5-10 feet taller than existing poles to allow proper wire clearance above the ground. Work is scheduled to begin in August, 2008, or as soon thereafter as possible, and will be completed by October, 2008, or as soon thereafter as possible.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. PG&E believes this project qualifies for the following exemptions:

- b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g) power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
