for the pole relocation of Manteca-Louise 60kV power line in the City

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

Pacific Gas and Electric Company (PG&E) proposes to relocate an approximately 458-foot long section (minor relocation) of the existing Manteca-Louise 60kV line to accommodate a road widening project in Manteca. One wood pole will be relocated approximately 30' to the west of the existing pole on South Airport Way at Yosemite Avenue in an existing franchise. Two self supporting guy stubs approximately 30' in height will be installed to provide an anchor for pole guy wires. Construction is scheduled to begin in January 2008 or as soon thereafter as possible, with completion in approximately one week or as soon as possible after construction begins.

- This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1., which exempts, "The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures" and "Power line facilities or substations to be located in an existing franchise, road widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for

which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.”

NOTICE OF PROPOSED CONSTRUCTION

Proposed Project: Pacific Gas and Electric Company (PG&E) proposes to relocate an approximately 458-foot long section (minor relocation) of the existing Manteca-Louise 60kV line to accommodate a road widening project in Manteca. One wood pole will be relocated approximately 30' to the west of the existing pole on South Airport Way at Yosemite Avenue in an existing franchise. Two self supporting guy stubs approximately 30' in height will be installed to provide an anchor for pole guy wires. Construction is scheduled to begin in January 2008 or as soon thereafter as possible, with completion in approximately one week or as soon as possible after construction begins.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- Power line facilities or substations to be located in an existing franchise, road widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
