**Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the construction of the US Wind Power Tap 60kV Pole Line relocation Project**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

In order to accommodate the Zone 7 Water Agency Altamont Water Treatment Plant Project, the Water Agency has requested that PG&E relocate two wood poles and a portion of the US Wind Power Tap 60kV Power Line. The project involves removing 2 wood poles and approximately 1000 feet of power line to accommodate the new Water Treatment Plant and replacing it with 3 poles and approximately 1000 feet of new power line. The new poles will be the same material and approximate size as the existing poles. The power line currently runs along a Wind farm access road in an east to west direction, at the location of the planned Altamont Water Treatment Plant, just west of Dyer Road, in eastern Alameda County. The new line will run in the same general direction, but approximately 120 feet south of the existing power line.

Construction is expected to begin in February, 2008, or as soon possible thereafter, and will be completed in approximately three days.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1 which exempts, "the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

### **Protests**

## NOTICE OF PROPOSED CONSTRUCTION

**Proposed Project:** In order to accommodate the Zone 7 Water Agency Altamont Water Treatment Plant Project, the Water Agency has requested that PG&E relocate two wood poles and a portion of the US Wind Power Tap 60kV Power Line. **Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
