for the Lammers-Kasson and Vierra-Tracy-Kasson 115kV  
Reconductoring Projects**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

In order to maintain service reliability and meet increasing electric load demands in Amador, Calaveras, Tuolumne, San Joaquin, and Stanislaus counties, Pacific Gas and Electric Company (PG&E) is proposing to reductor (replace the existing wires with new wires) approximately 4000' of the existing Lammers-Kasson 115kV and Vierra-Tracy-Kasson 115kV power lines, which are co-located on the same steel towers in this location. The project will consist of replacing the existing wires with new wires (replacement of existing facilities) on the existing towers in the same alignment (existing public utility easement) along Kasson Road between Interstate 5 and West 11<sup>th</sup> Street in San Joaquin County. To meet existing standards for the new conductor, one wood pole southwest of the Kasson Substation will be replaced with a tubular steel pole (TSP) of approximately the same height, and moved approximately 10' to the south of the existing pole within the existing easement (existing public utility easement). Construction is scheduled to begin in March 2008 or as soon thereafter as possible, with completion in approximately four weeks or as soon as possible after construction begins.

- This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1., which exempts, “The replacement of existing power line facilities or supporting structures with equivalent facilities or structures” and “Power line facilities or substations to be located in an existing franchise, road widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.”

**Proposed Project:** In order to maintain service reliability and meet increasing electric load demands in Amador, Calaveras, Tuolumne, San Joaquin, and Stanislaus counties, Pacific Gas and Electric Company (PG&E) is proposing to reconductor (replace the existing wires with new wires) approximately 4000' of the existing Lammers-Kasson 115kV and Vierra-Tracy-Kasson 115kV power lines, which are co-located on the same steel towers in this location. The project will consist of replacing the existing wires with new wires (replacement of existing facilities) on the existing towers in the same alignment (existing public utility easement) along Kasson Road between Interstate 5 and West 11<sup>th</sup> Street in San Joaquin County. To meet existing standards for the new conductor, one wood pole southwest of the Kasson Substation will be replaced with a tubular steel pole (TSP) of approximately the same height, and moved approximately 10' to the south of the existing pole within the existing easement (existing public utility easement). **Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- Power line facilities or substations to be located in an existing franchise, road widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
