Subject: Notice of Construction, Pursuant to General Order 131-D, for the Construction of the Carneras-Taft 70 Kilovolt Power Line Pole Replacement Project, County of Kern

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

Proposed Project: Occidental of Elk Hills, an oil company in Taft (Kern County), is proposing to expand their existing oil fields. In order to meet Occidental's increased electric demand, Pacific Gas and Electric Company (PG&E) must replace the wires (conductor) on an existing electric distribution line with new wires (reconductor) on the electric distribution system that services Occidental. In order to accommodate the electric distribution reconductoring, the Carneras-Taft 70 kilovolt power line will require replacing 25 wood poles (existing facilities) that currently support portions of the distribution line that requires the new conductor. The existing transmission line parallels Highway 33 and is situated within an existing county easement (existing easement). The pole replacement project will begin at a point on the northwest side of Highway 33, slightly northwest of Shale Road, and end at a point northwest of Elm Avenue, all in the City of Derby Acres. The new poles, which will support both distribution and existing transmission lines, will be approximately 5 feet taller than the existing poles. Construction is tentatively scheduled to begin in March 2008, or as soon thereafter as possible, and is scheduled for completion in July 2008, or as soon thereafter as possible.

Proposed Project: Occidental of Elk Hills, an oil company in Taft (Kern County), is proposing to expand their existing oil fields. In order to meet Occidental's increased electric demand, Pacific Gas and Electric Company (PG&E) must replace the wires (conductor) on an existing electric distribution line with new wires (reconductor) on the electric distribution system that services Occidental. In order to accommodate the electric distribution reconductoring, the Carneras-Taft 70 kilovolt power line will require replacing 25 wood poles (existing facilities) that currently support portions of the distribution line that requires the new conductor. The existing transmission line parallels Highway 33 and is situated within an existing county easement (existing easement). The pole replacement project will begin at a point on the northwest side of Highway 33, slightly northwest of Shale Road, and end at a point northwest of Elm Avenue, all in the City of Derby Acres. The new poles, which will support both distribution and existing transmission lines, will be approximately 5 feet taller than the existing poles. Construction is tentatively scheduled to begin in March 2008, or as soon thereafter as possible, and is scheduled for completion in July 2008, or as soon thereafter as possible.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- (b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- (g) power line facilities or substations to be located in an existing franchise, road widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist:

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
