Subject: Supplemental Filing for Procurement of Renewable Energy Resources Resulting from a Power Purchase Agreement between Geysers Power Company, LLC and PG&E.

Purpose:

Pacific Gas and Electric Company ("PG&E") hereby submits to the California Public Utilities Commission ("Commission" or "CPUC") a supplemental filing for Advice Letter 3211-E, dated February 15, 2008. The purpose of this supplement is to amend certain terms and conditions in the power purchase agreement ("PPA") between PG&E and Geysers Power Company, LLC ("Geysers"), to conform to the non-modifiable standard terms and conditions ("STCs") defined in CPUC Decision (D.) 07-11-025, Attachment A.

D.07-11-025, issued November 19, 2007, adopted language for four non-modifiable STCs that must be included in contracts between electrical corporations and projects selling electricity subject to the Renewables Portfolio Standard ("RPS"). The amendment to the PPA between PG&E and Geysers ensures that the PPA conforms to all non-modifiable STCs as defined in D.07-11-025, Attachment A.

In support of this supplement, the following confidential information is being submitted under the confidentiality protection of Section 583 of the Public Utilities Code and General Order 66-C. Pursuant to the Administrative Law Judge's Ruling Clarifying Interim Procedures for Complying with D.06-06-066, issued August 22, 2006 in Rulemaking 05-06-040, a separate Declaration Requesting Confidential Treatment of the confidential information is being submitted concurrently with this supplement.

PG&E provides a copy of the amendment to the PPA in confidential Appendix A.

**DECLARATION OF GARRETT P. JEUNG
SEEKING CONFIDENTIAL TREATMENT
FOR CERTAIN DATA AND INFORMATION
CONTAINED IN ADVICE LETTER 3211-E-A
(PACIFIC GAS AND ELECTRIC COMPANY ID U 39 E)**

I, Garrett P. Jeung, declare:


1. I am presently employed by Pacific Gas and Electric Company (“PG&E”), and have been an employee at PG&E since 2003. My current title is Senior Director within PG&E’s Energy Procurement organization. In this position, my responsibilities include managing a department that negotiates power purchase agreements and manages electric portfolio risk. In carrying out these responsibilities, I have acquired knowledge of PG&E’s contracts with numerous counterparties and have also gained knowledge of the operations of electricity sellers in general. Through this experience, I have become familiar with the type of information that would affect the negotiating positions of electricity sellers with respect to price and other terms, as well as with the type of information that such sellers consider confidential and proprietary.

2. To the best of my knowledge and experience and my understanding of the “Administrative Law Judge’s Ruling Clarifying Interim Procedures For Complying With Decision 06-06-066,” issued August 22, 2006, I make this declaration seeking confidential treatment of “Appendix A to Advice 3211-E-A,” submitted on March 21, 2008. By this supplemental filing, PG&E is supplementing previously filed Advice 3211-E, which seeks this Commission’s approval of a PPA that PG&E has executed with Geysers Power Company, LLC.

3. Attached to this declaration is a matrix identifying the data and information for which PG&E is seeking confidential treatment. The matrix specifies that the material PG&E is seeking to protect constitutes the particular type of data and information listed in Appendix 1 (the “IOU Matrix”) of D.06-06-066. The matrix also specifies the category or categories in the

IOU Matrix to which the data and information corresponds, and why confidential protection is justified. Finally, the matrix specifies that: (1) PG&E is complying with the limitations specified in the IOU Matrix for that type of data or information; (2) the information is not already public, except the terms and conditions that are non-modifiable according to Decision 07-11-025; and (3) the data cannot be aggregated, redacted, summarized or otherwise protected in a way that allows partial disclosure. By this reference, I am incorporating into this declaration all of the explanatory text in the attached matrix.
