Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

The Company has been requested by Tejon Industrial Corporation to relocate the existing Rose Tap 70 kilovolt power line to allow development of Tejon Industrial Corporation property near the intersection of State Route 5, Wheeler Ridge Road, and Laval Road in Kern County, approximately 25 miles south of the City of Bakersfield. The existing Rose Tap 70 kilovolt power line currently connects off of the Tejon-Lebec 70 Kilovolt power line near the intersection of Laval Road and Wheeler Ridge Road. The Company will remove the existing Rose Tap 70 kilovolt power line (approximately 1300 feet of power line) currently located along the easterly edge of Wheeler Ridge Road. The existing power line to be removed consists of 4 wood poles approximately 60 feet in height (leaving 45-foot tall poles to support 12 kilovolt underbuild). The Company will install approximately 1600 feet of 70kV power line which will connect off of the existing Tejon-Lebec 70 Kilovolt power line at a location approximately 1900 feet northwesterly of the existing Rose Tap 70kV power line (minor relocation) and extend easterly to the existing customer owned substation currently being served by the existing Rose Tap 70 kilovolt power line. The new line will be supported by five 60-foot wood poles and one 75-foot wood pole. The one taller pole is required to comply with

State Route 5 crossing clearance requirements. Work will begin in April, 2008, or as soon thereafter as possible, and will be completed by May, 2008, or as soon thereafter as possible.

Exemption from CPUC Authority: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption:

- c) the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing structures.

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Rose Tap 70 Kilovolt Power Line Relocation, County of Kern
ADVICE LETTER NUMBER: 3215-E

Proposed Project: Pacific Gas and Electric Company (PG&E) has been requested by Tejon Industrial Corporation to relocate the existing Rose Tap 70 kilovolt power line to allow development of Tejon Industrial Corporation property near the intersection of State Route 5, Wheeler Ridge Road, and Laval Road in Kern County, approximately 25 miles south of the City of Bakersfield. The existing Rose Tap 70 kilovolt power line currently connects off of the Tejon-Lebec 70 Kilovolt power line near the intersection of Laval Road and Wheeler Ridge Road. PG&E will remove the existing Rose Tap 70 kilovolt power line (approximately 1300 feet of power line) currently located along the easterly edge of Wheeler Ridge Road. The existing power line to be removed consists of 4 wood poles approximately 60 feet in height (leaving 45-foot tall poles to support 12 kilovolt underbuild). PG&E will install approximately 1600 feet of 70kV power line which will connect off of the existing Tejon-Lebec 70 Kilovolt power line at a location approximately 1900 feet northwesterly of the existing Rose Tap 70kV power line (minor relocation) and extend easterly to the existing customer owned substation currently being served by the existing Rose Tap 70 kilovolt power line. The new line will be supported by five 60-foot wood poles and one 75-foot wood pole. The one taller pole is required to comply with State Route 5 crossing clearance requirements. Work will begin in April, 2008, or as soon thereafter as possible, and will be completed by May, 2008, or as soon thereafter as possible.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- c) the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing structures.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
