Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to accommodate a road widening project in the City of Elk Grove, PG&E has been requested by Waterman Park, LLC to relocate one tower on the existing Gold Hill-Eight Mile Road 230kV power line in Sacramento County. PG&E will relocate the tower from its present location on the north side of Grant Line Road east of Waterman Road to a new location in the same alignment (existing public utility easement) approximately 55 feet (minor relocation) to the north. To ensure adequate conductor to ground clearance and to meet minimum separation requirements with an existing SMUD high voltage line, a base extension and a top cage extension will be added to the lattice steel tower, increasing the height approximately 39 feet. Adjacent transmission facilities in this industrial and commercial area include a Sacramento Municipal Utility District 230kV tower line and a 69kV wood pole line, as well as a Western Area Power Administration 230kV tower line. Construction is scheduled to begin in April 2008 or as soon thereafter as possible, with completion in approximately two weeks or as soon as possible after construction begins.

- This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1., which exempts, “The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures” and “Power line facilities or substations to be located in an existing franchise, road widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.”

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: GOLD HILL-EIGHT MILE ROAD 230KV TOWER RELOCATION, CITY OF ELK GROVE
ADVICE LETTER NUMBER: 3216-E

Proposed Project: In order to accommodate a road widening project in the City of Elk Grove, PG&E has been requested by Waterman Park, LLC to relocate one tower on the existing Gold Hill-Eight Mile Road 230kV power line in Sacramento County. PG&E will relocate the tower from its present location on the north side of Grant Line Road east of Waterman Road to a new location in the same alignment (existing public utility easement) approximately 55 feet (minor relocation) to the north. To ensure adequate conductor to ground clearance and to meet minimum separation requirements with an existing SMUD high voltage line, a base extension and a top cage extension will be added to the lattice steel tower, increasing the height approximately 39 feet. Adjacent transmission facilities in this industrial and commercial area include a Sacramento Municipal Utility District 230kV tower line and a 69kV wood pole line, as well as a Western Area Power Administration 230kV tower line. Construction is scheduled to begin in April 2008 or as soon thereafter as possible, with completion in approximately two weeks or as soon as possible after construction begins.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- The minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.
- Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
