**Subject: Submits Notice of Construction, Pursuant to General Order 131-D,  
for the Replacement of 18 Poles in Sanger-California 70 Kilovolt  
Power Line, County of Fresno, City of Fresno**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

In order to accommodate the replacement of 12 kV distribution wires attached to poles below the Sanger-California #1 70 Kilovolt (kV) power line in the City of Fresno, Pacific Gas and Electric Company (PG&E) will be replacing approximately 18 wood power poles on the existing line located along the northerly side of Jensen Avenue between Clovis Avenue and Chestnut Avenue. The poles to be replaced are grouped into 4 sections, the first consisting of six (6) poles located approximately 740 feet west of Clovis Avenue and extending westerly for approximately 1,472 additional feet. The second section consists of three (3) poles located approximately 200 feet west of Minnewawa Avenue and extending westerly for approximately 350 additional feet. The third section consists of four (4) poles located approximately 936 feet east of Willow Avenue and extending easterly for approximately 1,035 additional feet. The last section consists of five (5) poles starting at the northwest corner of Chestnut Avenue and Jensen Avenue and extending easterly for approximately 1,500 feet. In order to maintain legal ground clearances, most poles will be increased approximately 5' in height (most existing poles are approximately 55' – 65' tall), some will remain the same height, and approximately 4 poles will be raised approximately 10' in height. Work is

scheduled to begin in April, 2008, or as soon thereafter as possible, and will be completed by July, 2008, or as soon thereafter as possible.

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption:

- b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

**PROJECT NAME: Sanger-California #1 70kV – Distribution Reconductor, County of Fresno**

**Proposed Project:** In order to accommodate the replacement of 12 kV distribution wires attached to poles below the Sanger-California #1 70 Kilovolt (kV) power line in the City of Fresno, Pacific Gas and Electric Company (PG&E) will be replacing approximately 18 wood power poles on the existing line located along the northerly side of Jensen Avenue between Clovis Avenue and Chestnut Avenue. The poles to be replaced are grouped into 4 sections, the first consisting of six (6) poles located approximately 740 feet west of Clovis Avenue and extending westerly for approximately 1,472 additional feet. The second section consists of three (3) poles located approximately 200 feet west of Minnewawa Avenue and extending westerly for approximately 350 additional feet. **Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
