Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

In order to accommodate the replacement of 21 kV distribution wires attached to poles below the Kern-Old River #2 70 Kilovolt (kV) power line in the City of Bakersfield, the Company will be replacing approximately 9 wood power poles (replacement of existing facilities) on the existing line located along the southerly side of Panama Lane (existing franchise) between South H Street and Monitor Street. In order to maintain legal ground clearances, most poles will be increased approximately 5' in height (most existing poles are approximately 60' tall), two will remain the same height (70' tall), and one 40' tall wood distribution pole will be raised approximately 25' in height to match the height of the other transmission poles. Work is scheduled to begin in May, 2008, or as soon thereafter as possible, and will be completed by August, 2008, or as soon thereafter as possible.

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption:

- b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

## NOTICE OF PROPOSED CONSTRUCTION

**PROJECT NAME:** Kern-Old River #2 70kV – Distribution Reconductor, County of Kern  
**ADVICE LETTER NUMBER:** 3236-E

**Proposed Project:** In order to accommodate the replacement of 21 kV distribution wires attached to poles below the Kern-Old River #2 70 Kilovolt (kV) power line in the City of Bakersfield, Pacific Gas and Electric Company will be replacing approximately 9 wood power poles (replacement of existing facilities) on the existing line located along the southerly side of Panama Lane (existing franchise) between South H Street and Monitor Street. In order to maintain legal ground clearances, most poles will be increased approximately 5' in height (most existing poles are approximately 60' tall), two will remain the same height (70' tall), and one 40' tall wood distribution pole will be raised approximately 25' in height to match the height of the other transmission poles. Work is scheduled to begin in May, 2008, or as soon thereafter as possible, and will be completed by August, 2008, or as soon thereafter as possible.

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g) power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
