Subject: Notice of Proposed Construction of Facilities Pursuant to General Order 131-D, Clear Lake – Eagle Rock 60kV Pole Replacement Project, Lake County (Lakeport to Lower Lake)

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

Pacific Gas and Electric Company (PG&E) plans to replace 24 deteriorated wood poles with new wood poles (replacement of existing facilities) along the Clear Lake – Eagle Rock 60 kilovolt (kV) power line in Lake County. The pole line begins near Lakeport, north of the intersection of State Highway 29 and Highland Springs Road, and traverses southeasterly to Lower Lake near the junction of State Highway 29 and North Drive. All poles are located in existing easement except for 6 poles located in franchise within a 1.5 mile portion of the power line in Merritt Road between Davis Drive and Renfro Road. PG&E will replace 16 existing wood poles with new wood poles of the same approximate height, 7 poles with poles approximately 5 feet taller, and one pole approximately 10 feet taller to comply with the Commission's General Order 95 clearance requirements. Construction is proposed to begin May 19, 2008, or as soon as possible thereafter, and project completion is scheduled for September 1, 2008, or as soon as possible thereafter.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, B.1, which states that a Permit to Construct is not required for;

- "The replacement of existing power line facilities or supporting structures with equivalent facilities or structures."
- "Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement."

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Clear Lake – Eagle Rock 60kV Pole Replacement Project, Lake County (Lakeport to Lower Lake)

ADVICE LETTER NUMBER: 3244-E

Proposed Project: Pacific Gas and Electric Company (PG&E) plans to replace 24 deteriorated wood poles with new wood poles (replacement of existing facilities) along the Clear Lake – Eagle Rock 60 kilovolt (kV) power line in Lake County. The pole line begins near Lakeport, north of the intersection of State Highway 29 and Highland Springs Road, and traverses southeasterly to Lower Lake near the junction of State Highway 29 and North Drive. All poles are located in existing easement except for 6 poles located in franchise within a 1.5 mile portion of the power line in Merritt Road between Davis Drive and Renfro Road. PG&E will replace 16 existing wood poles with new wood poles of the same approximate height, 7 poles with poles approximately 5 feet taller, and one pole approximately 10 feet taller to comply with the Commission's General Order 95 clearance requirements. Construction is proposed to begin May 19, 2008, or as soon as possible thereafter, and project completion is scheduled for September 1, 2008, or as soon as possible thereafter.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- (b) the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- (g) power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
