Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of Marysville-Nicolaus 60kV Electric Distribution Underbuild Installation in the County of Yuba

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

To accommodate the installation of 21 kV electric distribution wires attached to poles below the Marysville-Nicolaus 60 Kilovolt (kV) power line near Olivehurst in Yuba County, Pacific Gas and Electric Company will be replacing approximately 14 wood power poles (replacement of existing facilities) in the existing easement (existing easement) on the existing transmission line located roughly parallel to Highway 70 south of Algodon Road and north of Abrozo Way. To maintain legal ground clearances, most poles will be increased approximately ten feet from 50 feet to 60 feet tall, four 55 foot tall poles will be replaced with 60 foot tall poles, and one 50 foot pole will be replaced with a 70 foot tall pole to provide adequate clearance over the railroad tracks. Construction is expected to begin in May 2008, or as soon as possible thereafter, and project completion is scheduled for September 2009, or as soon as possible thereafter.

This project qualifies as exempt from Permit to Construct filing requirements, pursuant to G.O. 131-D, Section III, Subsection B.1. which exempts "power line

facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts” and “the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.”

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

NOTICE OF PROPOSED CONSTRUCTION

Proposed Project: To accommodate the installation of 21 kV electric distribution wires attached to poles below the Marysville-Nicolaus 60 Kilovolt (kV) power line near Olivehurst in Yuba County, Pacific Gas and Electric Company will be replacing approximately 14 wood power poles (replacement of existing facilities) in the existing easement (existing easement) on the existing transmission line located roughly parallel to Highway 70 south of Algodon Road and north of Abrozo Way. Construction is expected to begin in May 2008, or as soon as possible thereafter, and project completion is scheduled for September 2009, or as soon as possible thereafter.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- The replacement of existing power line facilities or supporting structures with equivalent facilities or structures
- Power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist:

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
